**Narrative:**

On February 17, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (Bynum) and SA Allison Fletcher (Fletcher) contacted the resident of 315 Ira Avenue, Kimberly Furman (Furman). Furman stated that the Ring doorbell camera on her house contained video of the incident, but due to the motion activation it did not capture the entire incident. Furman was provided with an email address to send a link to the videos, and it was confirmed that the videos were sent. SA Bynum downloaded the videos and labeled them as "2025-02-17 315 Ira Ave 1" and "2025-02-17 315 Ira Ave 2" and then uploaded them into Evidence.com under "Reference Item A - CCTV Videos".

SA Bynum then spoke with John Smith Jr (Smith), the owner of the white Toyota Camry involved in the incident with license plate number LENBOY. Smith provided written consent to search the vehicle and stated that the backpack inside the vehicle was not his. The written consent form is attached to this report.
