L. Parkinson, of Mansfield, Ohio. This contract covers the construction and completion of general contract for heating in new service building and base bid portion of greenhouse, Ohio Agricultural Experiment Station, Wooster, Ohio, as set forth in Item No. 18 of the form of proposal dated January 27, 1930. Said contract calls for an expenditure of three thousand three hundred (\$3,300.00) dollars.
