Narrative:

On June 26, 2025, BCI Special Agent Lurna McClintock assisted SA Allison Fletcher and the Bureau of Criminal Investigation's Force Investigations Unit with the processing of a Ford F-150 located at Brooklyn Police Department (8000 Memphis Ave, Brooklyn, Ohio 44144) in regard to an Officer Involved Critical Incident. 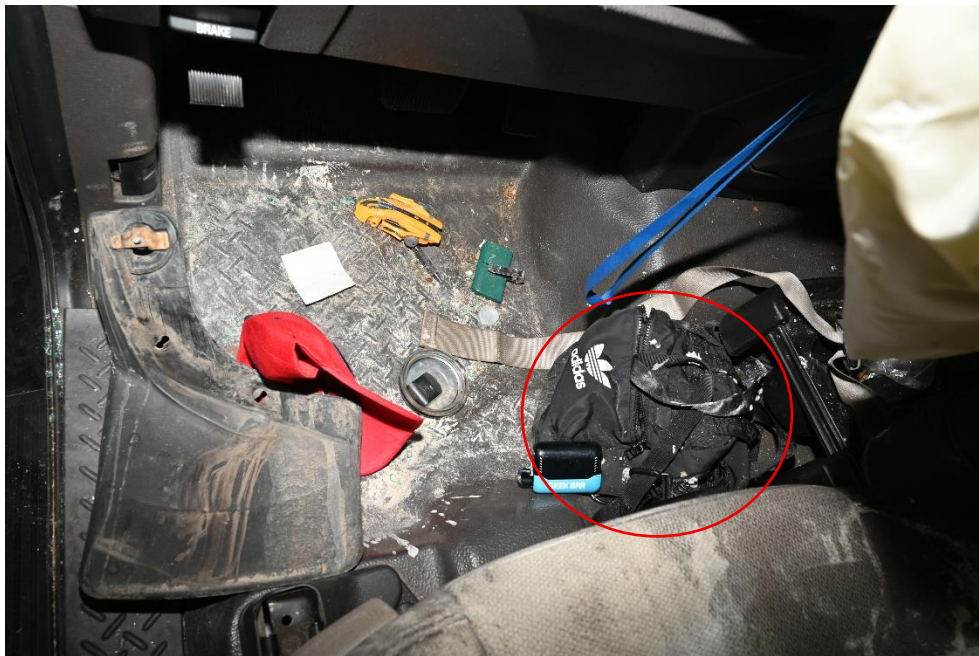


Figure 3: Location of Black Bag containing Evidence Items #2-4

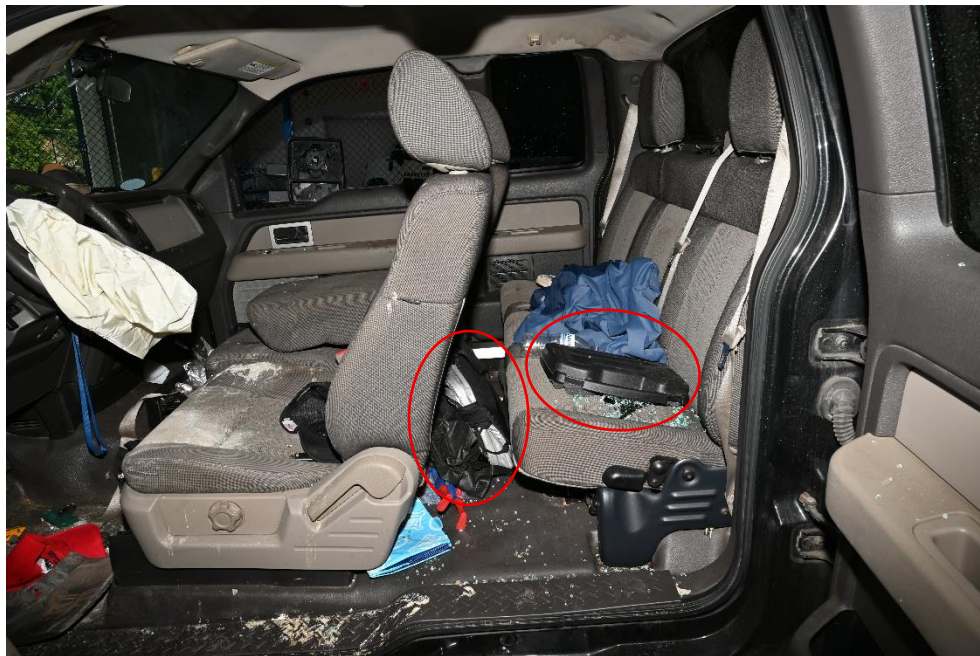


Figure 5: Location of Backpack containing Evidence Item #5 and location of Evidence Item #6

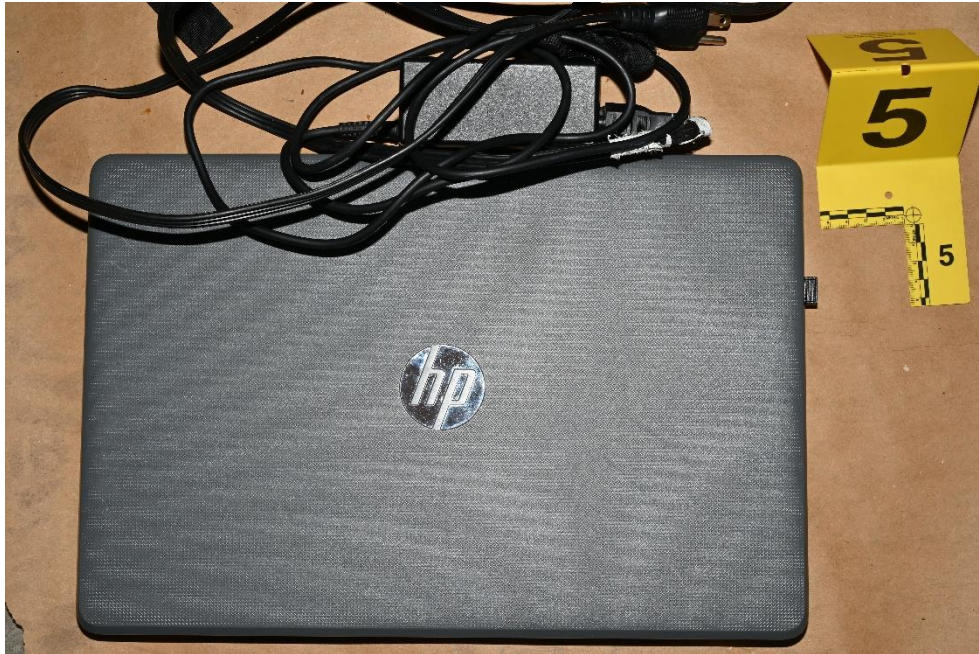


Figure 6: Evidence Item #5

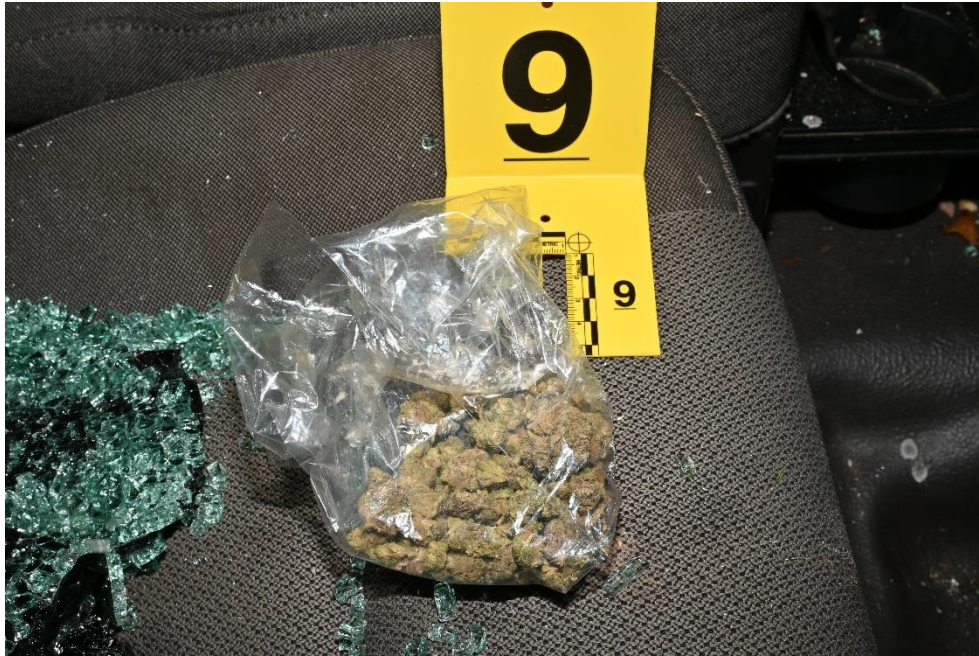


Figure 10: Evidence Item #9
