DEAR SIR: You have submitted for my examination a written petition bearing over one hundred names, containing a proposed constitutional amendment and a summary of the same under section 4785-175, General Code. It is proposed to amend the Constitution of the State of Ohio by adding a new section to Article XII relative to the appro-

priation and use of revenues accruing from any tax or fee for the registration, ownership, or operation of motor vehicles and from any tax on gasoline and other motor vehicle fuels and lubricants used in motor vehicles.
