Narrative:

On Monday, July 28, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (SA Tingley) reviewed Body Worn Camera (BWC) video footage from the Parma Police Department (PPD). SA Tingley was notified that the videos contained footage from the body cameras recorded regarding the Officer Involved Critical Incident which occurred in the area of Tiedeman Road and I-480 in Brooklyn, Ohio.

The video recordings were stored and accessed via AXON Justice (Reference Item N – BWC – BWC and Dash Cam, Sub Folder Parma PD Dash-Body). The videos will be documented and listed individually by title, type of video, duration, summary (by PPD Officer badge/unit number as names are not listed) and as to relevance related to the actual Officer Involved Critical Incident.
