Narrative:

Three firearms were recovered from the backyard of the subject's residence while processing the crime scene at 205 US 250, Polk, Ohio. An NCIC check of those firearms returned two stolen entries associated with the serial number stamped on the Sturm Ruger pistol (serial number 96749). However, the stolen entries associated with this serial number were entered in connection with a Sako Forester .243 caliber rifle and a Kel-Tec P-11 9mm pistol. The actual Sturm Ruger pistol found near the subject was not entered as stolen. The other two firearms recovered near the subject returned no results.

On September 7, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente received and reviewed the "Firearms Trace Summary" reports from the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) for the Arsenal Co. Bulgaria Makarov 9 pistol (S/N: BA221587) and the Iver Johnson Target .22 caliber revolver (S/N: N44842). [REDACTED]

On September 29, 2023, SA Valente received and reviewed the "Firearms Trace Summary" reports from the ATF for the Ruger Standard .22 caliber pistol (S/N:96749). [REDACTED]



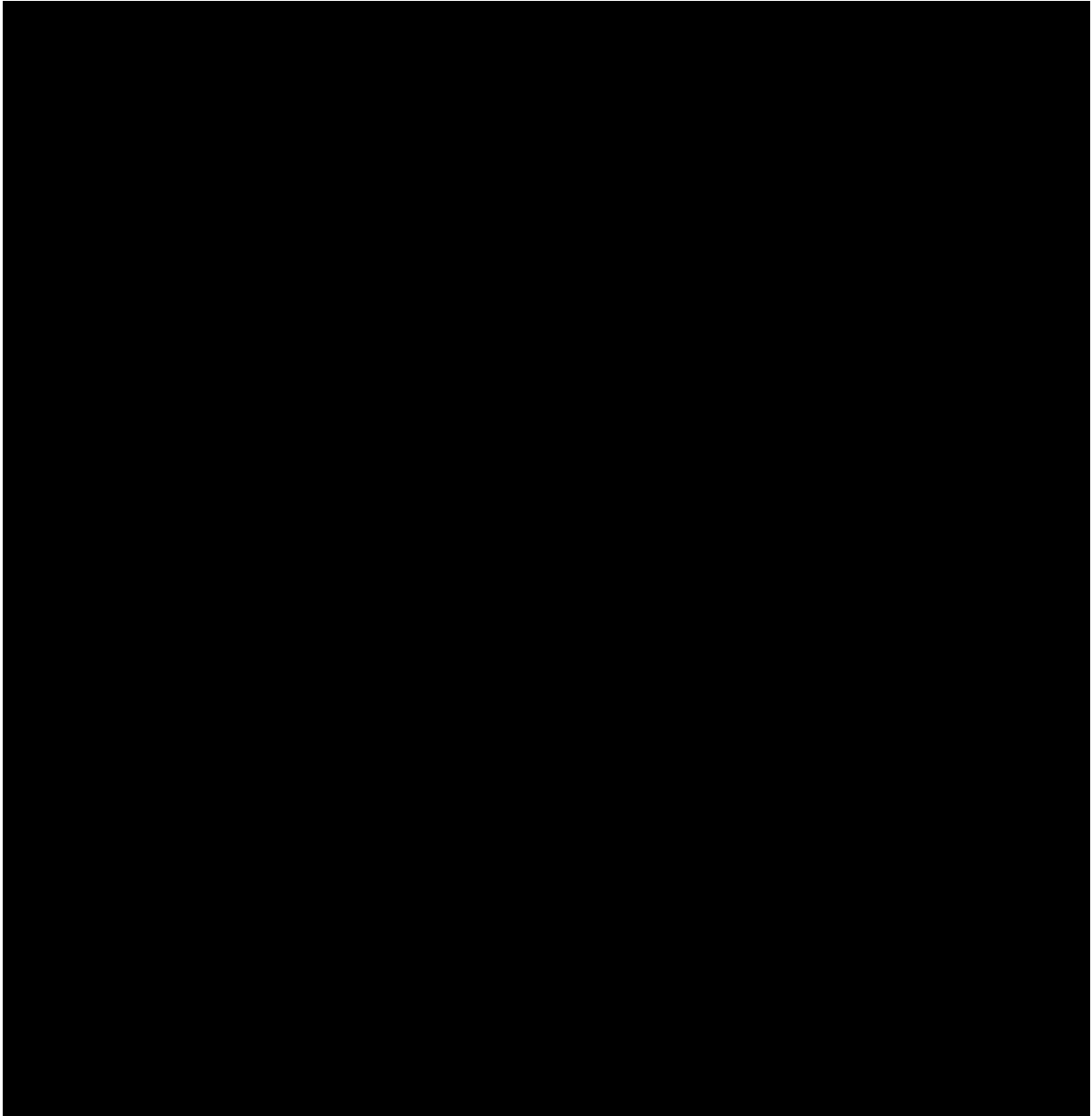
