#### Narrative:

On Tuesday, March 08, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Butterworth (SA Butterworth) received documents from Franklin County Sheriff's Office (FCSO) Sgt. Billy Duffer. The records which were requested included any reports pertaining to the March 7, 2022, officer-involved shooting, except for any statements made by the involved officers. SA Butterworth reviewed the documents and noted the following:

FCSO Detective Sgt. Billy Duffer provided two police reports for the officer involved incident. The first is a confidential investigative report that was brief and contained information about the involved person to the incident, Rayshawn Meeks, who is listed as a victim. The report briefly describes a shooting incident involving deputies from FCSO on the 7<sup>th</sup> floor of the Franklin County Parking Garage Complex.

The second report provided was a public incident report. There was only a victim name and date of birth listing Rayshawn Meeks and no other information included.

There are no further police reports that have been written or provided from the Franklin County Sheriff's Office.
