Narrative:

On Thursday, February 13, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (SA Valente) compiled background information on Mason French (French), a subject involved in the officer-involved shooting on January 16, 2025. The information included researching past police reports involving the subject, searching criminal history records, and court records (if applicable). The information gathered was obtained from the BCI Criminal Intelligence Unit and the Alliance Police Department (APD).

Prior Police Encounters:

APD had 32 documented prior interactions with French. The records of these interactions included police reports, CAD calls, and arrest records.

SA Valente reviewed the information and noted the following:

The collection of CAD calls contained brief notations of relatively minor or noncriminal interactions between French and members of the APD with the exception of one entry. This entry (CAD CALL 24150123) documented an incident that occurred on March 28, 2024. During the March 28, 2024, incident, French called police and reported Stacy Pride (Pride) "busted into his apartment" and was refusing to leave. When the police arrived, Pride left without any issues. A notation of "no violence reported" was contained in the narrative for this incident.

The collection of Incident Reports documented further interactions between French and APD. These records included an incident in 2002, when French reportedly pushed his then girlfriend out of a moving vehicle and tried to strike her with his car. In 2005, French reportedly assaulted another ex-girlfriend who required medical treatment at a hospital for her injuries. In a 2006 incident, French reportedly snuck up behind a man and held a knife to his throat while he threatened the other man.

The arrest records noted previous arrests for some of the above-described incidents as well as warrant arrests made for crimes committed in other jurisdictions.
