On May 30, 2022, at approximately 0300 hours, I, Ptl. M. Lowe #563, along with other Maple Heights Police units responded to 15310 Fernway Dr. for a report of shots fired.

Upon my arrival, I spoke with the resident, later identified as Chara Thompson. Chara stated she was in her bedroom sleeping. Chara stated at call 0300 hours she was awakened by multiple gun shots striking her home. Chara stated after hearing the shots she ran upstairs to check on her child, later identified as Charla Williams (24). Chara reported that herself and Charla were not injured by the gun shots that entered her home. Chara stated she believed that the previous tenant, Shatwoyne Cummings was possibly involved. Maple Heights Police units located a total of 22 bullet marks in the home. I observed a vehicle, a blue 2008 Chevrolet Cobalt, (RP: HYK3015 VIN: IGIAL58F387234047) that was parked in the driveway. The vehicle's back windshield was completely shattered by a gunshot.

I then spoke with the caller, Natreasha Edwards, who resides at 15312 Fernway Dr. Natreasha stated around 0250 hours she and her children were awakened by the sounds of multiple gunshots. Natreasha stated she her son, 10Y/O N [REDACTED], were asleep in his bedroom. Natreasha's 14Y/O N [REDACTED] was asleep in the living room on the couch. Natreasha stated the bullet went through the west side of the home and struck the wall where N [REDACTED] was sleeping. Natreasha stated after the bullet struck her home, she and her children laid on the floor for safety. At that time Natreasha called 911 for assistance.

I then spoke with Demarco Henderson who witnessed the incident occur. Demarco stated he parked his vehicle in front of 15310 Fernway Dr. to pick up his girlfriend, Jordanne Jones. Demarco stated he observed a gray Ford Focus (unknown registration #HYK3015) traveling west bound on Fernway Dr. Demarco stated he started to hear multiple gunshots coming from the vehicle. At that time, Demarco stated he ducked his head under the steering wheel to avoid being struck by gunfire. Demarco stated he then exited his vehicle to check for bullet marks, but none were found. Demarco did not report any injuries. Demarco had 4 bullet marks in the passenger side of his vehicle, which he stated were from a prior incident.

Maple Heights Police units canvassed the area of the home to attempt to locate shell casings. I located one 9mm Luger round in the street in front of 15312 Fernway Dr. Photographs of the shell casing were taken. I gathered the shell casing and placed it into an evidence envelope. Photographs of the bullet holes to the residence of 15312 Fernway Dr. were taken. Officers cleared from the call at approximately 0410 hours.

At approximately 0414 hours Ptl. Frazier and Ptl. Westfield were at the service garage when they heard one gunshot coming from Fernway Dr. While Maple Heights Police unit were enroute to Fernway Dr. the suspect vehicle a, gray Ford Focus was observed by Ptl. M. Mijangos and Cdt. Duncan traveling eastbound on old Granger Rd. at a high rate speed. Ptl. M. Mijangos and Cdt. Duncan pursued the Ford into Cleveland. (For more detail see Ptl. M. Mijangos, Ptl. M. Mijangos #551 supplement.)

Maple Heights Police units advised over the radio that the suspect crashed the vehicle on Buckeye Road at Mc Curdy Ave. (Cleveland, Ohio) and then fled on foot. While I was enroute Cdt. T. Duncan advised over the radio that shots had been fired. Once I arrived to the scene I exited my patrol vehicle (4428) and ran southbound on Mc Curdy to assist other Maple Heights Police units at 2747 McCurday Ave. I observed a black male lying on the grass in the front yard and he had a gunshot wound to his lower left torso. Cleveland EMS Squad arrived and transported the subject to University Hospital Main Campus located at 11100 Euclid Ave. where he was pronounced deceased at 0454 hours.

On May 30, 2022 at approximately 0300 hours, I, Ptl. Frazier, along with Ptl. Lowe and Ptl. Westfield, responded to the area of Fernway Drive for a report of shots fired. Dispatch advised the caller reported hearing approximately seventeen shots.

Upon arrival, I spoke with a group of four people who were standing on the sidewalk near 15310 Fernway Drive. A female stated she was stopped in her vehicle when she observed a gray or silver... Ford Focus drive over the curb on the North side of the road. The female then stated she observed the Ford Focus slow down near 15310 Fernway Drive and she heard several gunshots. The female then observed the Ford travel at a high rate of speed westbound on Fernway Drive. The parties stated they did not wish to identify themselves or provide written statements.

I then spoke with the resident of 15312 Fernway Drive, Natreasha Edwards. Natreasha stated she was asleep in her bedroom with her son, Naeem Scott (9 year-old). Natreasha's other son, N [REDACTED] (14 year-old) was asleep on the living room couch. Natreasha stated she heard several gunshots, when she awakened she grabbed N [REDACTED] and N [REDACTED] and held them down on the floor and called 911.

I approached the residence of 15310 Fernway and instructed asked Ptl. Lowe to show me where the bullet strikes were to the residence. The female resident, Chara Thompson, stated her house was struck with bullets on May 7, 2022, reference incident number 22-10091075. Chara pointed out the bullet strikes from today's incident. I marked the bullet strikes with the date and numbered each bullet strike that Chara identified. I then asked Chara which bullet strikes were from May 7, 2022, once again she pointed out the bullet strikes from May 7th, I marked the date "5/7" on each bullet hole.

Ptl. Lowe photographed the scene and collected the single casing which lied in the roadway near 15310 Fernway Drive; see Ptl. Lowe's supplement for further.

Ptl. Westfield and I cleared the scene and drove to the Maple Heights Service Department to get gas for my marked Maple Heights Police cruiser # 4401, located at 5501 Dunham Road, just North of Fernway Drive. At approximately 0414 hours, while at the Service Department, Ptl. Westfield asked me if I heard a gunshot and I told him "no". I asked Ptl. Westfield how many gunshots he heard and which direction he heard it from and he replied "Fernway". Ptl. Westfield updated other Maple Heights Units; reference incident number 22-10109615. I began driving South on Dunham Road from the Service Department and I observed a silver vehicle at a distance ahead travelling at a speed that I approximately to be 45 mph. I initiated a traffic stop on the vehicle, and discovered the vehicle to be a silver Chevrolet Cobalt, bearing OH registration # HYK3015; that vehicle was found not to be involved. I informed the responding units to check the area of Granger Road, Libby Road and Broadway Avenue. Ptl. Mijangos asked for the suspect's vehicle description and I advised him the vehicle was believed to be a silver Ford Focus, according to witness testimony. Ptl. Mijangos advised he observed a Ford Fusion travelling East on Granger Road at a high rate of speed. Ptl. Mijangos advised the vehicle was not stopping for his emergency signals and a pursuit ensued.

Ptl. Mijangos provided updated directions of travel, street names and speeds as I attempted to catch up to him and his trainee, Ptl. Duncan. Ptl. Westfield followed closely behind me. Ptl. Mijangos advised the vehicle crashed on Buckeye Road and suspects were running on foot. I asked dispatch for an exact location of the cruiser that Ptl. Mijangos and Ptl. Duncan were driving. Dispatch was able to locate them by the GPS equipped in the marked Maple Heights Police Cruisers. Dispatch provided the location of Buckeye Road near

McCurdy Street. I arrived to the last known location of Ptl. Mijangos and Ptl. Duncan. Upon arrival, I observed a person standing on the sidewalk on McCurdy Street, as I exited my vehicle I could hear Ptl. Duncan's voice coming from the direction of McCurdy Street.

Ptl. Westfield and I ran to Ptl. Duncan's location, where I observed a medium complexioned male with dread locs lying in a grassy area behind the chain linked fence of 2747 McCurdy Street. The fence had a rusted chain, looped around the closing of the fence, which kept the gate closed. The male was lying on his stomach and was slightly moving. We gave the male several commands to show Officers his hands, however he was not responding to our commands. Ptl. Duncan informed me that he did observe a firearm in the male's possession. A short time later, the male was no longer moving. Ptl. Westfield jumped the fence and Ptl. Duncan followed behind Ptl. Westfield and jumped the fence as well while I provided lethal coverage. At this time Ptl. Westfield and Ptl. Duncan placed the male in handcuffs. Cleveland Police arrived on scene and I noticed Ptl. Mijangos was not in the area. I made several attempts to located Ptl. Mijangos without success. Ptl. Mijangos advised via radio that he had one male in custody and would be walking back to the scene with the male. I met Ptl. Mijangos near the intersection of Buckeye Road near E. 93rd Street where he turned over a male subject to me, who I later learned to be Decarlo Fields. Decarlo was searched by Ptl. Westfield and placed in the rear of marked Maple Heights Police cruiser number 4423.

I informed dispatch of the VIN # 1FADP3F20GL280735 located on the driver door of the Ford Focus, which was left open. Dispatch informed that the vehicle was entered into LEADS as stolen NIC/V263960163; reference Cleveland PD incident number 2022-00137172.

While on scene, I was informed that a third suspect, later identified as O [REDACTED] F [REDACTED] was located at a bus stop. Cleveland PD transported that male to the scene where was positively identified by Ptl. Mijangos as one of the males he observed exit the Ford and flee on foot.

Title / Subject: MIJANGOS SUPPLEMENT

On May 30, 2022 at 0414 hours, I, Ptl. Mijangos #551 along with Cdt. Duncan #568, responded to a radio call from Ptl. Frazier #540 of gunshots near Fernway Drive. While enroute, Ptl. Frazier advised officers that a silver Ford was seen fleeing the area. At 0416 hours, I located a silver Ford Focus driving northbound on Granger Rd and took a high rate of speed turn onto Libby Road to travel eastbound.

Cdt. Duncan conducted a U-turn and attempted to stop the silver Ford, however, the Ford immediately began driving at a high rate of speed and drove through the red light on Libby Rd eastbound at Broadway Avenue. The Ford was ignored our lights and sirens by fleeing flee northbound on Lee Rd from Libby Rd at a rate of 80mph. At this time, Ptl. Frazier granted us permission to pursue this vehicle (see Pursuit Report MA22-10109615 for pursuit details). The Ford continued to flee at high rates of speed ranging from 50mph to 100mph throughout the city of Shaker Heights and Cleveland. While in Cleveland, the Ford was traveling approximately 80mph on Buckeye near McCurdy when it struck a deer and lost control by "fish-tailing". The Ford then attempted to turn southbound on McCurdy, however, e vehicle appeared to lose power, which caused us to strike the Ford on the driver-side. At this time, the vehicle pursuit ended, however, the driver, later identified as Datwuan Catchings, exited from the front driver-side and began fleeing on foot southbound on McCurdy (see Cdt. Duncan's Supplement for further details of this foot pursuit).

While Cdt. Duncan pursued Mr. Catchings, I observed two additional male passengers exit from the passenger side of the Ford. One male was wearing a blue hoodie sweat-shirt and then other male can be described as a young skinny black male wearing a black t-shirt. I began pursuing these males on foot westbound on Buckeye towards Steinway. These males were running in the same direction. I ordered them to stop, however they refused my order and began running eastbound on Steinway. Both males entered a high grassed field on the north-side of Steinway. Both males attempted to hide in the high grass, however I was able to locate the male in the blue hoodie, later identified as DeCarlo Fields, laying down in the field. Mr. Fields was immediately handcuffed and walked out of the high grass. I then heard a radio transmission from Cdt. Duncan of gunshots. I did not hear any gunshots as a train was passing over my head. While walking back to the police cruiser with Mr. Fields, I observed two unknown Cleveland police officers. I advised them of the other males location and provided them with his descriptions. In which a short time later, CPD officers located a male, identified as 17yo O [REDACTED] matching the description at a nearby bus stop. I positively identified O [REDACTED] as the other male who was running from me. Mr. Fields was transported to the Maple Heights Jail by Ptl. Lowe #563. O [REDACTED] was transported to the Maple Heights Jail by an unknown CPD unit.

The Officer was photographed in full uniform by Crime Scene & Records Detective Emerick#1908. The Officer was wearing a Maple Heights Police Uniform with an exterior vest cover. The vest cover had a MHPD Badge attached to the left upper chest. A wearable body camera was observed in the center of his vest cover. A cell phone and key were observed in the lower front pockets of his vest cover. The Officer was wearing a baseball cap with a Maple Heights patch located on the front of the hat. White lettering with the numbers 551 were stitched into the back of the cap. The Officer was wearing a duty belt that consisted of an empty hand cuff holder located in the right front. A holster was attached to the belt on his right side. Behind this holster on right rear of belt was a closed handcuff case. In the rear center of the belt was a protective glove pouch. His portable radio was mounted on the left side of the belt. A horizontal double magazine pouch was observed on the left front of the belt.

*\*The Officer handed his two magazines from his magazine pouch to Crime Scene & Records Detective Emerick #1908. The magazines were inspected and photographed. The magazines were found to be fully loaded with 17 rounds of duty ammunition. Cleveland Police IA Sgt. Sheehan #9130 monitored this magazine check.*

After conferring with Sgt. Reese #9266, I responded to the area of Buckeye Rd. and Mc Curdy Ave., to canvass the area, to process the scene and further investigate this incident.

### INTERVIEW:

On Monday, May 30<sup>th</sup>, 2022, while assigned to the Cleveland Police Department, Homicide Unit Car # 8188, off-duty capacity, I was advised by my supervisor, Sgt. #### SYNOPSIS:

- On Monday, May 30, 2022, at 0417 hours, CCS advised Fourth District Officers that Maple Heights PD was pursuing a vehicle into the City of Cleveland and they were requesting CDP's assistance. At 0426 hours CCS advised that the suspect vehicle had crashed into a guardrail in the area of Buckeye and McCurdy Avenue and three occupants had bailed from the vehicle.
- As the Officers were enroute they received additional information that there were shots fired in the area.
- Upon arrival, Officers were met by Maple Heights Officers who had one adult male, DeCarlo Fields (DOB 8-16-94), in custody.
- A second male, O [REDACTED] F [REDACTED] (DOB [REDACTED] 05), was apprehended by members of 4A34 at a bus stop on the southwest corner of Woodhill & Buckeye Avenue.
- Maple Heights Police Officer Duncan was in foot pursuit of the driver, later identified as DATWUAN CATCHINGS, who fled southbound on McCurdy Avenue armed with a firearm. CATCHINGS ran behind the garage of 2749 McCurdy Avenue. As Officer Duncan gave verbal commands, CATCHINGS turned towards Officer Duncan with the firearm in his hand at which time Officer Duncan fired one shot striking CATCHINGS in the left side.
- EMS #41 arrived and transported CATCHINGS to University Hospital where he was pronounced deceased at 0454 hours by Dr. McFarland.
- It was learned that Maple Heights Officers were involved in a shooting at this location.
- A full FIT call up was initiated and members of the FIT responded to both the scene and hospital.
- Homicide Unit, Internal Affairs, and Crime Scene responded.
- Several interviews were conducted on scene by members of the FIT Team.
- CSRU, Sgt. Rini, Detectives Emerick, Manson, and Johnson processed the scene.
- The arrested males (O [REDACTED] F [REDACTED] / DeCarlo Fields) were transported to Maple Heights PD. Members of the FIT responded to Maple Heights PD to conduct interviews.
- Preliminary investigation reveals Maple Heights PD were in pursuit of the suspect vehicle c/w shots fired into a habitation which occurred at approximately 0325 this morning on Fernway Avenue. Maple Heights PD encountered the suspect vehicle on Libby Road and attempted to conduct a felony traffic stop. The driver of the Ford Focus refused to stop and a pursuit ensued. The Ford Focus entered the city of Cleveland at approximately 0417 hours at which time Maple Heights PD requested assistance from CDP. At approximately 0426 hours Maple Heights PD advised CCS that the suspect vehicle had crashed and the suspects had bailed. Officer Duncan engaged in a foot pursuit of the driver who exited the vehicle with a firearm. The driver, CATCHINGS, ran behind the garage of 2749 McCurdy Avenue as Officer Duncan ordered CATCHINGS to stop. At some point, CATCHINGS, while climbing the privacy fence turned towards the Officer Duncan with the firearm in his hand. Officer Duncan fired one round striking CATCHINGS in the left side. Maple Heights PD administered lifesaving measures until the arrival of EMS.



- As CATCHINGS exited the suspect vehicle, Officer Duncan exited his zone car at which time the zone car continued to roll forward striking the Ford Focus' driver side door. The Maple Heights zone car sustained damage to the front passenger side.
- Maple Heights Police Chief, Todd Hansen, responded to the scene.
- AIU responded and handled the OH-1 Accident Report.
- ATF K-9 responded and assisted with locating a spent shell casing in the rear of 2749 McCurdy Avenue. This shell casing matches the rounds in Officer Duncan's weapon.
- One live round was located in the driveway of the above address. This round matches the rounds located in the extended magazine located in the front yard and the chambered round in CATCHINGS' firearm.
- CATCHINGS' firearm was located hanging on the privacy fence with a string attached.
- Upon running a check of the Ford Focus' VIN # we learned that it was reported stolen on 04-22-22. (Refer to LERMS #22-137172). D-4 to handle the GTMV Recovery Report.
- Detectives recovered a Springfield Armory, 9mm firearm, Serial #BA580558 in the rear passenger floorboard of the Ford Focus along with 3 spent shell casings. The vehicle was processed towed to Lot 2 – VIU #9745.
- FBI SA Andy Burke responded to University Hospital and assisted with identifying DATWUAN CATCHINGS using a Mobile Biometric Application.
- A walk-through was conducted by members of the FIT and Maple Heights Police Chief Todd Hansen.
- CCMEO Dr. Gilson and Investigator Sharken responded to the scene.
- Officer Duncan's firearm was confiscated by members of the FIT. Both Officers WCS cameras were taken by members of the Internal Affairs Unit to Maple Heights PD for download.

On Munday, May 30, 2022, I, Det. Christopher Faunce #528, stopped at 15408 Fernway Dr. to speak with a resident who was possibly a witness to the shooting.

I was advised on scene in Cleveland, by Ptl. Frazier #540 and Cleveland Police Sgt. Moore #9104, that a female who identified herself as Ginger B. had arrived on scene of the incident and stated the car that was involved was the car she saw shooting at the house in Maple Heights. Ginger was in a gray Audi with Florida plate EURW17. No other information other than a phone number was obtained at that time.

After leaving the scene in Cleveland, I responded back to process Fernway Dr. I observed a gray Audi bearing Florida plate EURW17 parked in the driveway of 15408 Fernway Dr. I asked Ptl. Lowe to contact that resident but he was unable to do so.

When I responded back to Fernway Dr. to process the inside of 15310 Fernway Dr. I observed the front door to 15408 Fernway Dr. open. I responded over and spoke with a female who identified herself as Ginger B. Ginger was later identified as Gindonya Bridges. When I first spoke with Gindonya she stated the following. She was parked in the street in front of her house and a friend of hers was parked directly beside her talking window to window. Her friend said "Damn they must be stealing or something." When her friend said that, she observed a car driving with no lights on traveling west on Fernway Dr. The car did not wait for her friend to move, instead it drove up on the tree lawn on the opposite side of the street to drive around them (three cars wide). The car then stopped and they heard gunshots. They heard approximately 15 gunshots. Another female that was inside the residence with Gindonya also made comments but no identification for that female was obtained. The unidentified female stated she believed they "empties the clip" (indicating fired all bullets from a magazine). Gindonya then stated she turned on a scanner app and the car that shot the house was the same car that crashed on Buckeye Rd.

I then advised the females the reason I was there was due to them going to Cleveland and identifying the car they saw shooting on Fernway Dr. was the same car they told Cleveland Police was on scene on Buckeye Rd.

Gindonya then asked if the car from Buckeye Rd. was the same car Warrensville Heights Police was chasing earlier in the day. Gindonya stated they have shot at that house previously. When asked if they would provide written statements, Gindonya stated they did not want to at this time.

\*\*\*Officer note: Warrensville Heights did chase a tan Ford but it was not the vehicle involved in this incident.\*\*\*

On Thursday, June 2, 2022, I responded back to speak with Gindonya and ask her to provide a written statement. Gindonya had been interviewed by the news on May 30, 2022 so I was hoping she would be willing to provide her statement.

Gindonya provided a statement and stated the following:

I was parked on the street and my friend pulled beside me. That's when we seen a car coming up toward Dunham with their lights turned out. They drove up on the curb to get around us. They then pulled up to the house down the street and began shooting at the house. When the police left they came back and shot one more time. When then listened to scanner and went to Buckeye and verified it was the same car.

Title / Subject: COUNTY PROSECUTOR REVIEW

I contacted Cuyahoga County Major Crime Prosecutor Saleh Awadallah and gave him the facts of the case. Cleveland Police are investigating the Use of Force Shooting of the suspect by our officer and he was assigning a special prosecutor for that review. Prosecutor Awadallah put me in touch with Joanna Whinery to get a ruling for charges for the juvenile and suggested I forward the information on the Adult suspect to County Prosecutor T. McKenna for review. The following synopsis was sent with copies of reports and witness statements for review:

We had 2 related shooting into habitation incidents yesterday morning. Both incidents involved the same house and same suspect vehicle. The first incident was at approximately 0300 (MA22-10109588) on 5-30-22 where a gray Ford drove past 15310 Fernway Drive and fired approximately 17 rounds striking 15312, 15310 and an unoccupied vehicle in the driveway of 15310. Both homes were occupied by adults and children at the time of the shootings. Witnesses at both scenes described the suspect vehicle as a gray Ford and that the shots were fired from the passenger side rear window. The second incident (MA22-10109615) occurred only minutes after officers cleared the first shooting scene at 0414 hours. Officers were only a short distance away at our service garage fueling their vehicles when they heard the shots. The suspect vehicle fled on Dunham Road where another officer responding to the call observed the vehicle on Dunham / Old Granger Road traveling at a high rate of speed away from the scene. Officers attempted to stop the vehicle they observed, a silver / gray Ford focus, but it continued to flee from officer who gave chase. The pursuit lasted from 0414 to 0425 hours reaching speeds approaching 100 miles per hour only ending when the subject vehicle struck a deer and crashed. The 3 occupants of the suspect vehicle fled on foot (the driver fleeing while carrying a handgun) and the officers gave chase. The driver fleeing with a gun (Datwuan Kain Catchings 22-years old) was shot by an officer during the foot chase on McCurdy and was later pronounced dead. The other officer apprehended the front seat passenger (DeCarlo Wilbert Fields 27-years old) near 9407 Steinway Ave. The rear seat passenger (O [REDACTED] A [REDACTED] F [REDACTED] 17-years old) was later apprehended at a bus stop by Cleveland Police Officer a short time later near Woodhill and Buckeye. The suspect vehicle had no license plate and when the VIN was run was found to be stolen out of Cleveland OCA/2022-00137172.NIC/V263960163. The vehicle was a 2016 Ford Focus Tectonic Silver Metallic (could be described as a light gray) with vin # 1FADP3F20GL280735 and should have had a license plate of HPD6862.

Through further investigation and interviews conducted by the detective bureau we learned that the female occupant / victim of 15310 Fernway had a romantic relationship with the driver of the suspect vehicle (Datwuan Kain Catchings 22-years old) who had spent the night at her residence on Saturday 5/28/22 going into Sunday 5/29/22 and left at approximately 1700 hours (5pm) on Sunday 5/29/22 after an argument where he allegedly believed the occupants of the home smoked all of his marijuana without his consent. This appears to be the motive for the shootings into the home that occurred Sunday night 5/29/22 going into Monday morning 5/30/22 at 0300 and 0414 hours.

On Monday, May 30th 2022 at approximately 0417 hours while assigned to 4A34 with my partner P.O. Pesta #981, radio made a broadcast that Maple Heights Police Department was in pursuit of a vehicle in our district. The following are the facts of the incident.

Radio continued to broadcast MHPD's location as they continued to pursue the suspect vehicle throughout the 4th District. After some time, radio broadcasted that the suspect vehicle hit a deer and crashed at Buckeye and McCurdy, and that MHPD officers were engaged in a foot pursuit of three suspects that fled from the vehicle on foot. 4S34, Sgt. Schroeder #9249 gave permission for ourselves and other 4th District zone cars to assist MHPD officers. While enroute to the area, radio advised us that one of the suspects was shot, another suspect was in custody, and that there was still a suspect fleeing in the area on foot. Upon our arrival, we conferred with MHPD officers who stated that the suspect still at large ran through the fields in the area of Buckeye and McCurdy. They described the suspect male being a black male wearing a black shirt and black pants. Ourselves and other 4th District zone cars toured the surrounding streets in search of the suspect.

While touring the area, we observed a younger black male, wearing a black shirt and black pants with no shoes on, sitting by himself at the bus shelter located at Woodhill Rd and Buckeye Rd. We advised radio of our location, and that we would be checking this male. We then made contact with the male, later identified as O [REDACTED] A. H [REDACTED] (DOB: [REDACTED] 2005), and placed him in handcuffs (double-locked) without incident. (F [REDACTED] stated that he was waiting for his mother to pick him up, and that he asked a stranger to use their phone to contact his mother. (F [REDACTED] did not have any shoes on, and MHPD officers advised us that the suspect that fled had sandals. P.O. Pesta read (F [REDACTED] his constitutional rights, to which he acknowledged that he understood. (Fields) told us that he lived in Maple Heights.

Sir/Ma'am,

On Monday, May 30, 2022 at 0426 hours, in the company of PO. Surtz #1383, radio broadcasted that there was a vehicle pursuit initiated by Maple Heights Police Department in Maple Heights in connection with shots fired in their city, that resulted in a motor vehicle accident on Buckeye Rod near McCurdy Avenue. Radio then broadcasted that there were three males running from the vehicle.

While en route to this location we were informed by radio that shots had been fired. Upon our arrival, we observed a Maple Heights Officer that was coming from the north west corner of East 93 Street and Buckeye Road, with one male detained (later identified as DeCarlo Fields). At the same time he shouted that another male wearing all black was in the high grass north of Buckeye and McCurdy. At this point we began to search the high brush in the fields north of Buckeye and McCurdy. We exited the brush on Steinway Avenue and continued north with negative results.

Once we arrived back on scene, we were then informed that the Maple Heights Officer had been involved in a shooting at 2794 McCurdy Avenue, and the shot male (later identified as Datwuan Catchings) was transported by Medic 41 to University Hospital.

We then returned to the crime scene where we began the crime scene log, process tow sheet, and secured the crime scene. A short while later, 4A34 found a male matching the description of the male that fled the scene, at a bus stop on the southwest corner of Woodhill and Buckeye. The male (O [REDACTED] F [REDACTED]) was found wearing no shoes and he told 4A34 (PO. Pesta #981, PO. Fitchwell #134) that he was waiting for his mother. He was then positively identified by Maple Heights Officers to be the other male who had fled from the vehicle. We also discovered that he is the brother of the male we originally saw detained.



The driver of the Maple Hts Police SUV, Officer Duncan, was in foot pursuit of Datwaun Catchings. The passenger of the Maple Heights SUV, Officer Mijangos was in foot pursuit of the second occupant of the suspect vehicle, later identifies as DeCarlo Fields. The third occupant of the suspect vehicle fled on foot and was later apprehended by Cleveland Police and identified as Omarion Fields.

Officers secured Datwuan Catching into handcuffs and rolled him over looking for the firearm. EMS was requested and first aid was being administered. Datwuan Catchings had one gsw to his left lower back. EMS 41 transported Datwuan Catchings to University Hospital where he was pronounced deceased at 0454 hours by Dr McFarland.

A full FIT call up was initiated and members of the FIT responded to both the scene and the hospital. AIU Officer Jason Hryn #578 responded to handle the OH-1 Accident report.

Maple Hts Officers secured Officer Duncan's service weapon and turned it over to SIU Detective Prock #384. The weapon was a Glock 19 9mm with Serial Number [REDACTED]. the hospital. A large amount of blood and an extended tan magazine loaded with four 9mm bullets was located at Dominion Gas Reader at the front of the residence. A trail of blood was located up the driveway to the backyard. One live RP 9mm Luger Bullet was located in the driveway in front of the garage. The back yard was closed in with a wooden privacy fence. Datwuan's clothing and property. These actions were monitored by IA Sgt Ilain #9239.

IA Sgt Young #9181, Homicide Detective Borden #43 and Homicide Detective Powell #2062 responded to Maple Heights Police Department to interview the arrested males.

Detective Borden#43 interviewed DeCarlo Fields after he advised him of his Miranda Rights. DeCarlo Fields was evasive on answering any questions of who was in the Ford Focus during the pursuit. DeCarlo Fields eventually admitted that he was in the front passenger seat, O [REDACTED] F [REDACTED] was in the back passenger seat and Datwuan Catchings was the driver. DeCarlo stated that he was picked up by Datwuan Catchings at Clement Avenue and Raymond Avenue. Maple Heights Police tried to pull them over but Datwuan Catchings refused to pull over. DeCarlo Fields stated they struck a deer during the pursuit and the airbags deployed. When the vehicle came to a rest they all fled the vehicle on foot. DeCarlo Fields denied knowing Datwuan Catchings real name, denied any knowledge of a shooting or firearms in the vehicle. It was later determined all three are related.

**ASSIGNMENT:** On Monday, May 30, 2022, while assigned to the Accident Investigation Unit (AIU), I received a page at 0440 hours to respond to Buckeye & McCurdy for a Maple Hts. pursuit that resulted in a crash. It was further reported that one male was in custody, one male was still not found and one male was shot. Sgt. Schroeder #9249 was requesting AIU and the incident number is 22-151034.

**SCENE:** I arrived on scene at Buckeye & McCurdy at 0506 hours and observed a Maple Heights police vehicle, a 2016 Ford Explorer, facing in a northeasterly direction across the double yellow line on Buckeye Road just west of McCurdy Avenue. A few feet west of the police vehicle, along the north curb of Buckeye, was a 2016 Ford Focus. This vehicle was facing easterly with its right front wheel on the roadside and right front end in contact with a metal guardrail. Within the intersection, in the E/B lanes of travel, was a debris and fluid area. A fluid trail continued from here to the current location of the Ford Focus. Leading to the debris field/fluid area was another fluid trail that began east near the double yellow line.

I spoke with Sgt. Moore. He informed me that the Ford Focus was being pursued by Maple Heights PD c/w a shooting outside a party in Maple Heights. The suspect car hit a deer further east on Buckeye and then the police car hit the suspect car. There was a foot pursuit and a shooting that followed. I walked the scene and observed a deer in the W/B curb lane of Buckeye near the north curb approximately 200 feet west of Ambler Street. Vehicle debris, from the Ford Focus, was observed on Buckeye beginning just east of Ambler and continuing westerly toward the location of the deer.

I briefly spoke with the driver of the police vehicle, Maple Heights Officer Duncan #568, before being asked to discontinue the interview by Maple Heights Officer Frazier. P.O. Duncan informed me that they were chasing the shooting suspects in the Focus on Buckeye. The Focus hit a deer somewhere back on Buckeye. The Focus started to weave right and he thinks it tried to cut him off and when he tried to stop, the police vehicle wasn't slowing and he hit the Focus on the door.

I spoke with the right front passenger of the police vehicle, Maple Heights Officer Mijangos #551. He informed me they (him and Maple Heights Officer Terrance Duncan #568) were pursuing the Focus W/B on Buckeye and it struck the deer at approximately 80-90 MPH. After striking the deer, the Focus continued W/B and was fishtailing a little but was not braking. It looked like at the last second the Focus tried to turn left onto McCurdy because he cut right in front of their police vehicle. Officer Mijangos further informed me that Officer Duncan was attempting to brake and when the Focus tried to cut, to avoid hitting the Focus in the rear, he jumped into the next lane partially and the police car hit them.

Buckeye Road in this area is also known as State Route 87. It is fairly straight with a 5% to 6% grade and a posted speed limit of 35 MPH. Buckeye conducts east/west traffic with two lanes in each direction. The surface is constructed of concrete east of Ambler Street and asphalt west of Ambler which was dry. Roadway markings consisted of a Double Yellow Line (DYL) and Broken White Lines (BWL). Two roadways, McCurdy Avenue and Ambler Street, which are 477 feet apart, intersect Buckeye along its south edge. Traffic control devices on Buckeye in this area consist of two electronic traffic signals suspended over each end of Buckeye at Ambler.



**VEHICLES:**

**2016 Ford Focus**, 4-doors, tan in color with Ohio license plate HPD6862 and Vehicle Identification Number (VIN): 1FADP3F20GL280735 was located at final rest as described above. The vehicle was reported stolen on May 17, 2022 with Cleveland report number 2022-137172. The listed owner is Robert S. Williams from Cleveland, OH. The 2016 Ford Focus sustained the following damage: the left rear door skin was crumpled and pushed forward; the left front door hinge was partially broken; severe frontal damage to the hood which was crushed and crumpled upward; all frontal components damaged including the grill, right front headlight assembly and header panel; the right fender was dented and scratched. All frontal and right-side side airbags were deployed, all windows remained intact, both front seatbelts were in the buckled position and a key was in the ignition. On Monday May 30, 2022 while off duty I received a request from Homicide Unit A/Lt. Teresa Gomez #9135 at 0626 Hrs to respond to University Hospital in connection with CAD 2022-151034 and meet Det. Charles Schultz #508 to assist with an identification.

I arrived at University Hospital Emergency Department at approximately 0650 Hrs.

### INVESTIGATION:

The unidentified individual was located in a room with Det. Schultz along with Internal Affairs Lt. Ilan and Det. Manson from CSRU. Neither the investigation, nor hospital staff had been able to positively identify the individual. Det. Schultz removed the paper bag from the individual's left hand. The right hand remained sealed in a brown paper bag and was not manipulated during the identification process. SA Burke collected fingerprints from the decedent's left hand using a Mobile Biometric Application to search Criminal Fingerprint Files of the Federal Bureau of Investigation Criminal Justice Information Services Division. The collection device was a "Watson Mini" which was cleaned with an alcohol swab, and allowed to dry, immediately prior to acquisition of the prints. Only the individual's left hand and wrist were manipulated during the collection process. The individual's left thumb pad was noted to have blood on it which could interfere with the collection process. It was cleaned with one alcohol preparation pad and allowed to air dry. No other chemicals were used, and cleaning or wiping of the rest of the fingers was not required. SA Burke wore latex gloves for contact with the individual's hand. 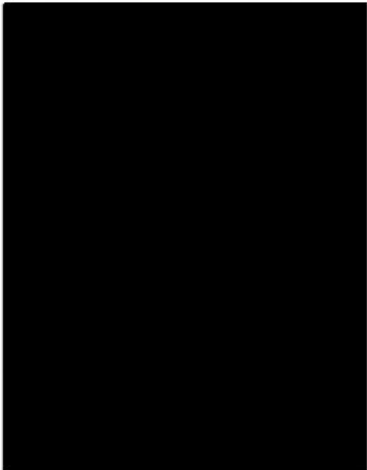
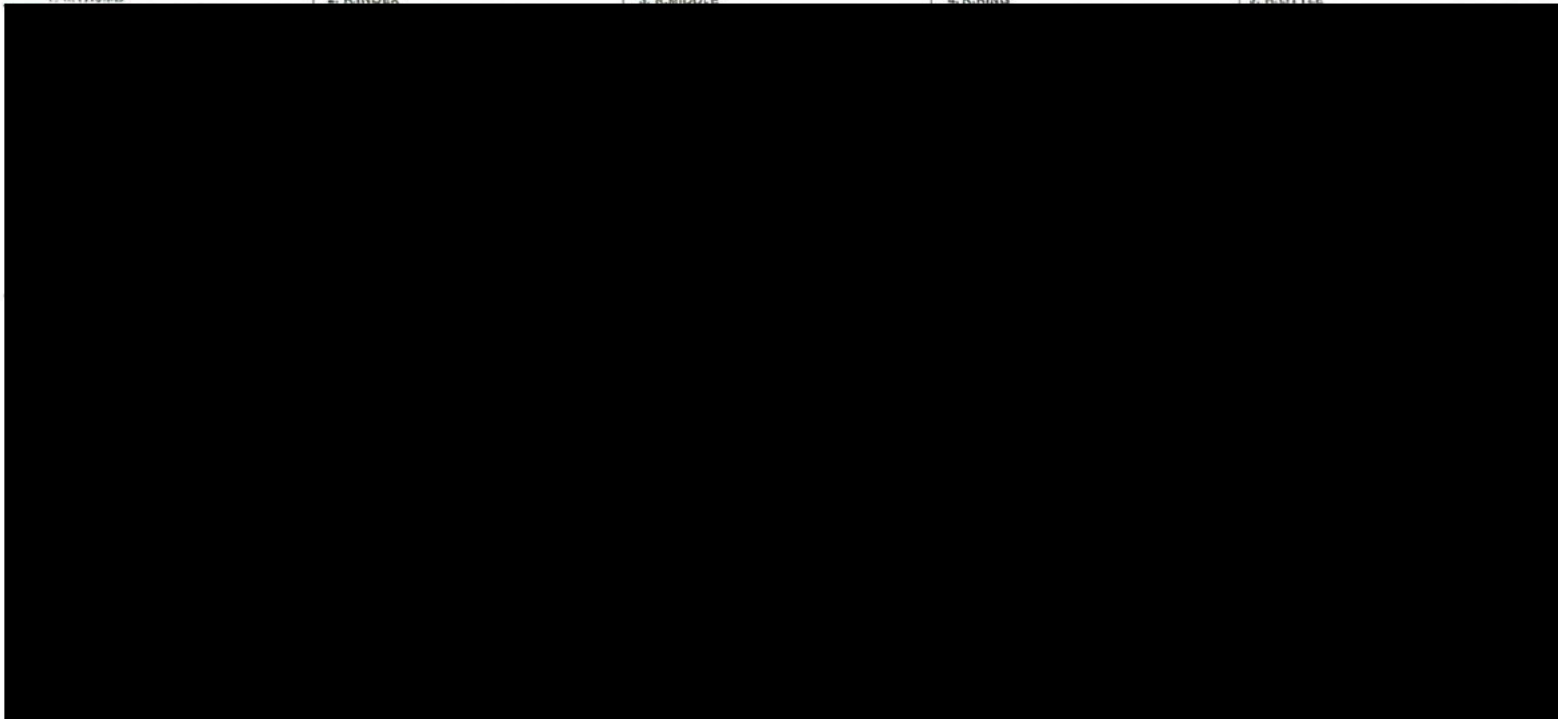
