APPROVAL.—TWO RESERVOIR LAND LEASES, STATE OF OHIO, THROUGH CONSERVATION COMMISSIONER, TERM FIFTEEN YEARS, ANNUAL RENTALS, LAND BUCKEYE LAKE, FAIRFIELD COUNTY AND INDIAN LAKE, LOGAN COUNTY, OHIO, LESSEES, ERWIN MARQUARDT, \$48.00; MARGARET STUBBS, \$75.00.

DEAR SIR: You have submitted for my examination and approval two reservoir land leases in triplicate, executed by the State of Ohio through you as Conservation Commissioner, to the lessees therein named, by which there were leased and demised to the lessees therein named certain parcels of reservoir land as therein described, owned by the state at Buckeye Lake, Fairfield County, and Indian Lake, Logan County, Ohio.

These leases, designated as to the names of the lessees, the location of the parcels of land leased, and the annual rental provided for therein, are as follows:
