Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) obtained a search warrant for the cellular phone that was recovered from



Recovered Cellular Phone

The cellular phone was analyzed by the BCI Cyber Crimes Unit (CCU). SA Momchilov was later provided the analysis in the XRY software format. SA Momchilov reviewed the analysis. Accounts discovered in the analysis are associated with email address rjfife2012@gmail.com.

Based upon the email associated with the accounts and other information in the analysis, SA Momchilov concluded that the phone was owned and possessed by Randall Fife (Fife)

As SA Momchilov was reviewing the analysis, he noticed that some information may not have been successfully extracted from the phone. For example, when reviewing the "Calls" the last documented call is a voice mail with the date and time of February 10, 2023, at 11:08:24 Am UTC. It is known to SA Momchilov that initial responding

Howland Township Police Officer Brandon McDaniel contacted Randall Fife via phone during his initial response. SA Momchilov was also aware that SRT (Special Response Team) negotiators attempted to contact Fife via phone.

Due to the discrepancies in the "Calls," SA Momchilov viewed the recovered cellular phone. SA Momchilov noted that there was a discrepancy between the XRY extraction and the physical phone.

<u>Calls</u>

The physical phone showed a total of 193 missed calls from phone number between 1139 hours on August 22, 2023, and 0206 on August 23, 2023.
