On Monday, April 4, 2022, at approximately 1015hrs, SA Boerner removed thirty-two (32) items of suspected evidence from temporary evidence to further document those items that needed further examination and to place evidence labels on the items of collected evidence (See photographs in Matrix for further).

Items further documented:

- Item 15 – Ballistic shield (United Shield International, model: Kent, S/N: 001, Protection level: IIIA). No suspected ballistic impacts were observed on the ballistic shield.
- Item 21 – Wallet recovered from the body of James Sheets. The wallet contained \$263.00 in currency, sixteen doses of Suboxone and IDs issued to multiple persons.
- Item 23 – Qty 2, plastic baggies of suspected methamphetamine were repackaged in plastic for lab submission.
- Item 24 – Qty 1, plastic baggie containing a white powder was repackaged in plastic for lab submission.
- Item 25 – Pink cell phone was examined for identifying information (Samsung, IMEI: 354325913231398).
- Item 31 – Duty belt (Capt. Matt Haus) was photographed and examined for items of suspected evidence. None were observed.
- Item 32 – Duty belt (Ofc. Tommy Schneeman) was photographed for items of suspected evidence. One item of suspected evidence was observed, collected and photographed (Item 33).
- Item 33 – Black taser S/N: [REDACTED], with one cartridge fired and one cartridge intact, recovered from Ofc. Schneeman's duty belt.
