**Search Warrant Obtained**

Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) drafted a search warrant for Matrix Item #48 – Black Apple iPhone relative to the officer-involved critical incident which occurred on May 3, 2024.

On Thursday, May 09, 2024, SA Goudy met with Summit County Court of Common Pleas Judge Alison McCarty (Judge McCarty). Judge McCarty reviewed the search warrant and search warrant affidavit. On May 9, 2024 at approximately 1200 hours, Judge McCarty signed / authorized the search warrant.

**Search Warrant Executed**

On Thursday, May 09, 2024, at approximately 1443 hours, SA Goudy executed / served the aforementioned search warrant by submitting the Apple iPhone to the BCI Cyber unit for analysis

During the search, the following items of potential evidence were seized:

No evidence was recovered due to no available passcode. Also, there was no available software to bypass the security code.

**Search Warrant Returned**

On Tuesday, June 04, 2024, SA Goudy met with Judge Kathryn Michael (Michael). Judge Michael reviewed and signed the search warrant return. On June 4, 2024, SA Goudy filed the original search warrant, search warrant affidavit, motion to seal, order to seal, and search warrant return with the Summit County Clerk of Courts.
