**Narrative:**

On Wednesday, July 30, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Dan Boerner (SA Boerner) reviewed the Parma Hts. surveillance video in reference to the Officer-Involved Critical Incident that occurred in Brooklyn, Ohio on Tuesday, June 24, 2025. The recordings were provided to Special Agent Allison Fletcher (SA Fletcher) and uploaded to Axon Justice on Thursday, July 17, 2025 (Reference Item P - Surveillance Video).

The surveillance video was gathered from two locations, Speedy Gas (6229 Pearl Rd.) and Yorktown Lanes (6218 Pearl Rd.). Each recording was reviewed in its entirety with the exception of the recording titled "ch14(CAM14)\_250624100133\_250624110612\_00\_719MB\_YORKTOWN.avi" (*Table 1, Surveillance Video*). This recording would not play. None of the recordings were relevant to the Officer-Involved Critical Incident investigation.
