**Narrative:**

On Tuesday, July 15, 2025, the Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Dan Boerner (SA Boerner) received documents from the Southwest Enforcement Bureau (SEB). The records were received by SA Allison Fletcher on Tuesday, July 15, 2025, and uploaded to Matrix (Tactical Dispatch TIMELINE.docx.pdf). The records which were requested included the report(s) pertaining to the Tuesday, June 24, 2025, Officer-Involved Critical Incident, except for any statements made by the officers involved. SA Boerner reviewed the documents and noted the following:

The SEB report is an "Operational Report Timeline" consisting of CAD/dispatch entries documenting radio traffic between SEB/SWAT officers. The first entry was at 1159hrs, and the final entry was at 1459hrs. The SEB report listed Dispatchers Flynn and Hamilton at the bottom of the report. The SEB report was reviewed in its entirety and those CAD/dispatch entries deemed most relevant to the investigation were listed in the table below (*Table 1, SEB Report*).
