NARRATIVE

On Thursday, July 2, 2020, at 1513 hours, while assigned to Z/C 3A21 with P.O. Meehan #2439, we received a code 3 radio assignment to respond to 1001 Huron Rd., Restore, for a civil dispute. Upon our arrival we made contact with Adam Wright (Interview) and he informed us of the following :

Wright (Interview) stated that he is the co-owner of Restore and that an employee, Zach Edwards (Suspect), made threats to the other co-owner, Christine Pratt (Victim). We made contact with Pratt (Victim) and learned that she was working in the kitchen with Edwards (Suspect) and he was making remarks. Pratt advised us that Edwards had a mask on and she could not understand him. Pratt asked Edwards to repeat what he was saying and Edwards became aggressive and started yelling and hitting items in the kitchen. Pratt remarked that at that point she opened the back door of the business and told Edwards to leave. Edwards replied "I'm not going anywhere " and then attempted to lunge at her. Pratt stated that another employee, Gregory Sims (Witness) was in the kitchen when the incident happened and he was able to "restrain" Edwards from advancing towards her.

Pratt explained that Edwards became very angry and started to make threats such as "Get's real, send them after y'all" and "I'll have rioters bust this store up" and he repeated eight times that " I'll kill you." Pratt explained that after a couple of minutes, Edwards relaxed and then attempted to lunge at her again. Sims (Witness) was able to restrain him again.

Pratt advised us that Edwards eventually left and stated that he would return tomorrow to work. Wright advised us that on Friday, July 2, 2020 he planned on firing Edwards from Restore and advise him to not return.
