Narrative:

On Thursday, September 11, 2025, at 1100 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joe Lamping (SA Lamping) received an email from Ashtabula County Sheriff's Office Lieutenant Matthew Johns which contained the Jefferson Emergency Rescue (JER) run report related to this investigation. The JER report was attached to this investigative report where it can be reviewed in its entirety.

SA Lamping reviewed the information on the JER run report and noted that the JER crew consisted of Paramedic Matt Anderson, who authored the JER report, and Paramedic/Registered Nurse Jacob Rice. Jerry Pegram (Pegram) was listed as the patient. The call for service was listed as being received at 1509 hours, and the JER crew was listed as being on scene at 1519 hours. The report indicated that Pegram was deceased prior to the arrival of EMS, illustrated in the snippet below:
