DEAR SIR:—You have submitted for my approval a contract entered into by the state of Ohio, acting through the Adjutant General, and the Frazeysburgh Lumber Company, a partnership composed of S. L. Huffman, B. B. White and W. M. Ashcraft, of Frazeysburgh, Ohio, for the erection of a state armory barn at Dresden, Ohio. This contract calls for an expenditure of \$6,024.60. Accompanying said contract is a bond signed by the Frazeysburgh Lumber Company, upon which R. W. Woodruff of Frazeysburgh, and P. H. Moore of Frazeysburgh, are sureties.

Evidence has further been submitted showing that this firm does not employ a sufficient number of men to require the insurance from the Industrial Commission. You have further submitted evidence showing that the controlling board has waived the provisions of section 6 of House Bill 301, relative to competitive bidding.

It further appears that the Department of Highways and Public Works approved plans and specifications which were duly prepared and submitted.

You have further submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated sufficient to cover the obligations of this contract.

Finding said contract and bond in proper legal form I have this date noted my approval thereon and return the same herewith to you, together with all other data submitted.
