Narrative:

On Tuesday, November 25, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joshua Welty (SA Welty) received requested records and recordings from Ohio State Highway Patrol (OSP) Sgt. - Caller: Nathaniel Rice
- Caller called into Brown County reporting a reckless vehicle.
- Caller provided a license plate of "JWF6376," describing the vehicle as a "Land Rover, newer model, has a silver bag hanging off the passenger side, roof rack, it's black and grey."
- Caller also stated the operator was a blonde-haired man.
- Caller stated the vehicle went into Arby's in Mount Orab.

- Caller: Kaylei (Uplift - Mount Orab)
- Caller called into Brown County reporting "someone in the parking lot waving a knife around, threatening the construction workers, across the street, um, he already left, but we do have his ID."

- Caller provided the driver's license number [REDACTED]
- Caller further stated "he was outside of his car, he put a vest on, and then started waving a knife around in the air, told the construction workers... I'm going to kill you and peeled out of here."
- Caller described the vehicle as a black SUV - Land Rover defender 130.
- Caller provided a name for the individual as Christopher Lindner.
