Narrative:

On July 8th and 9th, 2024, S/A Hammond and CST E. Miller had an opportunity to review photographs taken during the examination of 1917 Delence St. Toledo, Ohio. This crime scene examination took place on May 24th, 2024. Please refer to the corresponding investigative report.

The purpose of the May 24th examination was to locate any evidence that would establish Beau Purtee to the primary crime scene or offer insight into the motives of his potential actions. Special Agents searched for items of ammunition, a gun box or receipt to establish ownership of the weapon, notes, writings, and digital evidence. During the course of the examination S/A Hammond photographed each room of the home, including any firearms, ammunition or related items. This was done to document what weapons were present inside the home.

The review of photographs was conducted to determine if any rifle magazines were documented inside the home that were similar in make, model and construction to the rifle magazine submitted to the BCI Lab in Bowling Green by the Perrysburg Twp. PD.

Examination of crime scene photographs DMH_6342 through DMH_6347 depict a home office / guitar room east of the living room. The room has gray painted walls with white trim. Photos depict a light wood dresser with multiple drawers, a black office chair, a tool chest and electric guitars hanging on the ceiling.

Photographs were taken of the contents of the dresser drawers. A review of photograph DMH_6347 appears to show a magazine of similar design to the magazine submitted by the Perrysburg Twp.




