**Narrative:**

On May 20, 2024, Special Agent (SA) Josh Rammel (Rammel) reviewed the subject workup of involved individual Matthew Flynn (Flynn). Included in the workup was all information pertaining to Flynn's criminal and personal history.

SA Rammel observed the following criminal violations involving Flynn that are deemed important to the Officer Involved Criminal Incident (OICI) involving Flynn and involved officer [REDACTED].

1. On March 27, 2011, Flynn was arrested for Disorderly Conduct and Resisting Arrest by the Dade County Florida Sheriff's Office.
2. Flynn was the victim of an assault that took place on February 7, 2018, which was investigated by the Akron Police Department.
3. Flynn was the victim of a Burglary that took place on May 7, 2018, which was investigated by the Akron Police Department.
4. Flynn was charged by the Ohio Department of Liquor Control for Persistent Disorderly Conduct on April 28, 2012.
5. Flynn's only other criminal violations appear to all be traffic related minor misdemeanors. One of these violations by Flynn was issued an additional charge for Failure to Appear.

The complete criminal and personal subject workup were attached to this investigation. See the attachment for complete details.
