Narrative:

On Tuesday, December 20, 2022, the Marion County Sheriff's Office and Marion Police Department requested the assistance of the Ohio Bureau of Criminal Investigation (BCI) with the investigation of an Officer Involved Critical Incident which occurred in LaRue, Marion County, Ohio. During the investigation, Agents obtained Ohio Peace Officer Training Commission (OPOTC) records for **East** (**East**). Special Agent Stranahan reviewed those records and learned the following information.
