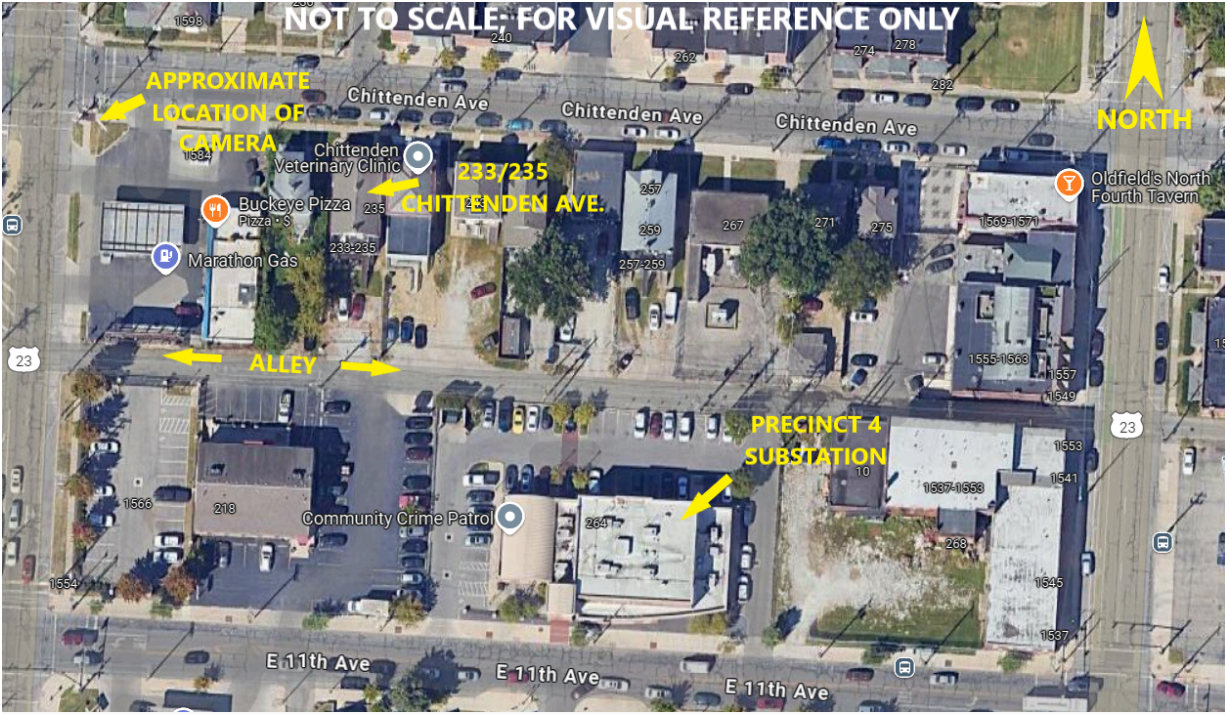

Narrative:

On September 23, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) James Gore reviewed video footage from the Marathon gas station, located at 1584 Summit St., Columbus, OH 43201. The footage was previously uploaded to the Axon™ database by Columbus Police Officer Dustin McKee on 9/10/2024, and it was relevant to an Officer-Involved Critical Incident which occurred on the same date in the rear parking lot of the Columbus Police Precinct 4 Substation. The footage is of the gas station lot, facing south-southeast from approximately the intersection of Summit Street and Chittenden Avenue.

The following images are screenshots from the video which were notable. The video did not have a date or time stamp; therefore, any times noted herein refer to the timer on the video, not the actual time of day. The footage did not contain audio, and the clip was 15 minutes in length.

Around the 2:58 mark and prior, an unidentified male wearing white or light-colored clothing walked from the alleyway south of the Marathon station, northbound, toward Chittenden Avenue. For time reference, the same male subject was observed on video from the Chittenden Veterinary Clinic, walking in the same alley behind 233/235 Chittenden Ave. on 9/10/2024 at approximately 0121 hours.

Around the 7:52 mark and just prior, a male, believed to be Lamine Mahmoudi (involved subject), walked from left to right in the alley (east to west), and peered around the corner down Summit Street. The subject then walked back eastward (left) in the alley.

At the 7:55 mark, as the subject walked back eastward in the alley, a shiny object appeared in the video. This was potentially one of the two knives recovered from Lamine Mahmoudi after his encounter with police behind the Precinct 4 Substation.

Around the 12:39 mark, several police vehicles entered the alley with emergency lights activated.

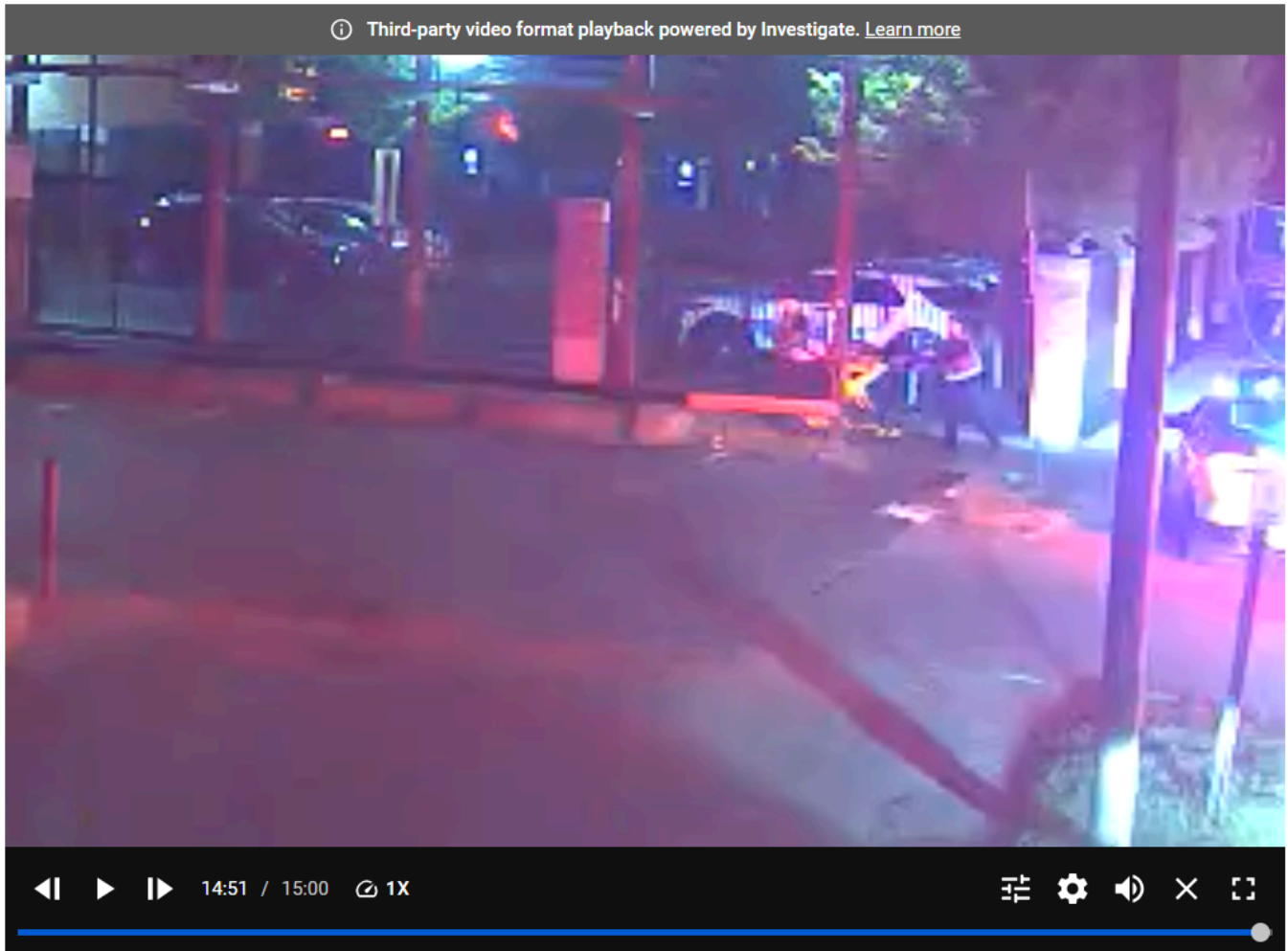
