On June 26, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente received an Ohio BCI Laboratory report for Matrix Item # 012, a Bryco Arms 9mm pistol that was recovered from the pants pocket of Jason Norris while he was receiving treatment at UH Saint John Medical Center, 29000 Center Ridge Road, Westlake, Ohio.

The pistol was submitted to the Firearms section of the BCI Laboratory on June 4, 2024. The laboratory report (report number 24-33473) was authored by Forensic Scientist Monica Coblentz.

SA Valente reviewed the report and noted the following:

• The pistol was determined to be intermittently operable due to worn parts identified within the firearm during a disassembly process.
