#### Narrative:

On March 22, 2023, at 1002 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) received an email from BCI Criminal Intelligence Unit (CIU) Analyst Andrea Bujorian (Bujorian). The email contained attachments with background information compiled by Analyst Bujorian on Fred Wild III (Wild), a subject involved with the incident and subsequent officer-involved shooting on March 21, 2023. The information included criminal history records, open/closed-source databased inquiries. Much of the information was included in a 63-page PDF document labeled, "Fred Wild Workup."

SA Moran reviewed the information and noted the following:

### • Fred Wild Workup

Page 1 – This page listed all of Wild's identifying information. It indicated that Wild had a Computerized Criminal History (CCH) in the Law Enforcement Automated Data System (LEADS) and in the Ohio Law Enforcement Gateway (OHLEG).

Pages 2-24 – These were OHLEG records for Wild. His license was suspended. It showed multiple Bureau of Motor Vehicle (BMV) convictions for a variety of offenses including:




