Details:

On July 6, 2022, at approximately 1120 hrs., S/A Justin Soroka retrieved the items collected by the Summit County Medical Examiner's Office during the autopsy of Jayland Walker. The items were previously received by S/A Arvin Clar and secured in temporary evidence lockers at the Ohio Bureau of Criminal Investigation in Richfield.

Thirty-two boxes, identified as containing projectiles, jackets and fragments were located in a paper bag. Each item was kept in its original packaging, placed in individual envelopes, and then sealed and initialed by S/A Soroka. The boxes were marked as Matrix Item #141 through Matrix #173.

Separate envelopes containing head and pubic hair samples were kept in their original packaging, placed together in an envelope, and identified as Matrix #174. Separate envelopes containing nail clippings from the right and left hands were kept in their original packaging, placed together in an envelope, and identified as Matrix #175. A DNA blood card was kept in its original packaging, then placed in an envelope and identified as Matrix Item #176. A fingerprint card was packaged in an envelope and identified as Matrix Item #177. A tooth recovered from a balaclava was kept in its original package, then placed in an envelope and identified as Matrix Item #178. Two hair bands taken from the wrist were kept in their original packaging, then placed in an envelope and identified as Matrix Item #179. All items were sealed and initialed by S/A Soroka.

A pair of handcuffs were removed from their packaging and photographed. The name [REDACTED] was observed engraved on the handcuffs. They were identified as Matrix #180, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A pair of Nike shoes were removed from their packaging and photographed. They were identified as Matrix #181, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A pair of socks were removed from their original packaging and photographed. They were identified as Matrix #182, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A pair of blue, Hanes underwear were removed from their packaging and photographed. They were identified as Matrix #183, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A black, do-rag was removed from its original packaging and photographed. It was identified as Matrix #184, placed back in its original packaging, and then sealed and initialed by S/A Soroka. A black, balaclava was removed from its original packaging and photographed. It was identified as Matrix #185, placed back in its original

packaging, and then sealed and initialed by S/A Soroka. A tourniquet from the left thigh, right thigh, and left arm were removed from their individual packages and photographed. They were identified as Matrix #186, #187, and #188, respectively, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A pair of black, Nike pants with a pink stripe were removed from their original packaging and photographed. They were identified as Matrix #189, placed back in their original packaging, and then sealed and initialed by S/A Soroka. A blue, t-shirt was removed from its original packaging and photographed. It was identified as Matrix #190, placed back in its original packaging, and then sealed and initialed by S/A Soroka. A black, Nike hooded jacket was removed from its packaging and photographed. It was identified as Matrix #191, placed back in its original packaging, and then sealed and initialed by S/A Soroka. A wallet containing miscellaneous cards, an Ohio driver's license belonging to Jayland Walker, an Ohio driver's license belonging to Jaymeisha Beasley, and \$46.00 in U.S. currency was photographed. The U.S. currency was packaged separately and identified as Matrix #193. The wallet and the remaining contents were identified as Matrix #192, placed back in their original packaging, and then sealed and initialed by S/A Soroka.

All items were secured in temporary evidence locker #10 at the Ohio Bureau of Criminal Investigation in Richfield.
