Ohio, and the State of Ohio, acting by Carl G. Wahl, Director of public Works, for the Board of Trustees of Kent State University, Kent, Ohio, for General Work for a project known as Engleman Hall and Addition to Lowry Hall, Kent State University, Kent, Ohio, as set forth in the Form of Proposal dated December 20, 1937, which contract calls for the total expenditure of one hundred and eighty-three thousand eight hundred and two dollars (\$183,802.00).
