APPROVAL—FORM OF AGREEMENT BY AND BETWEEN THE STATE OF OHIO AND THE WHEELING AND LAKE ERIE RAILROAD COMPANY COVERING THE INSTALLATION OF FLASHING LIGHTS, IN HURON, LORAIN, HARRISON, SUMMIT, STARK, COSHOCTON, JEFFERSON AND WAYNE COUNTIES.
