Approximately 01:59:20 into the footage, a waveform spike consistent with gunfire is observed.

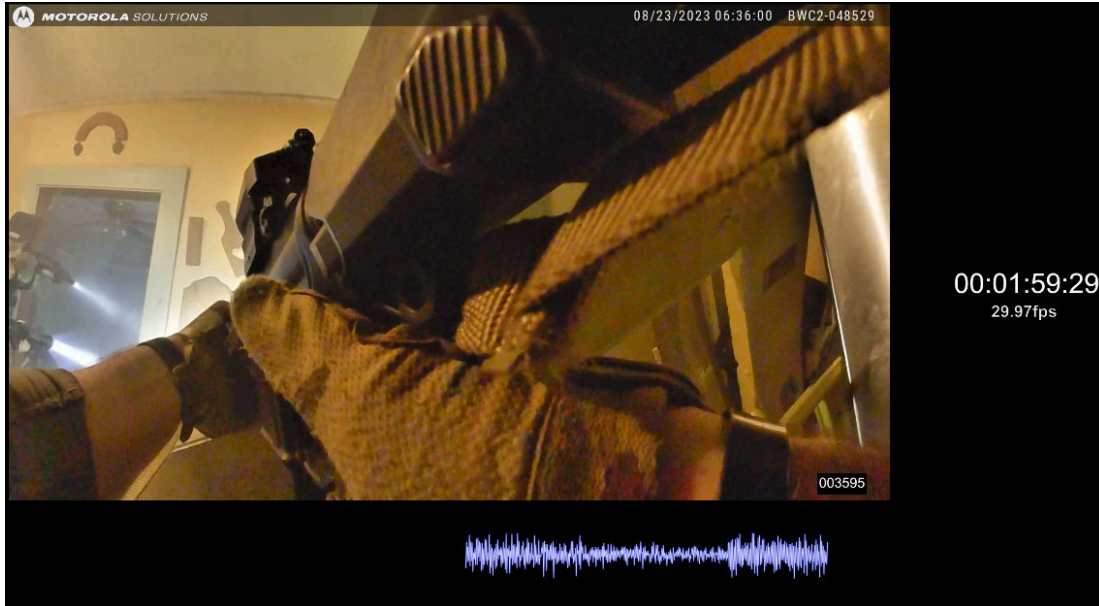

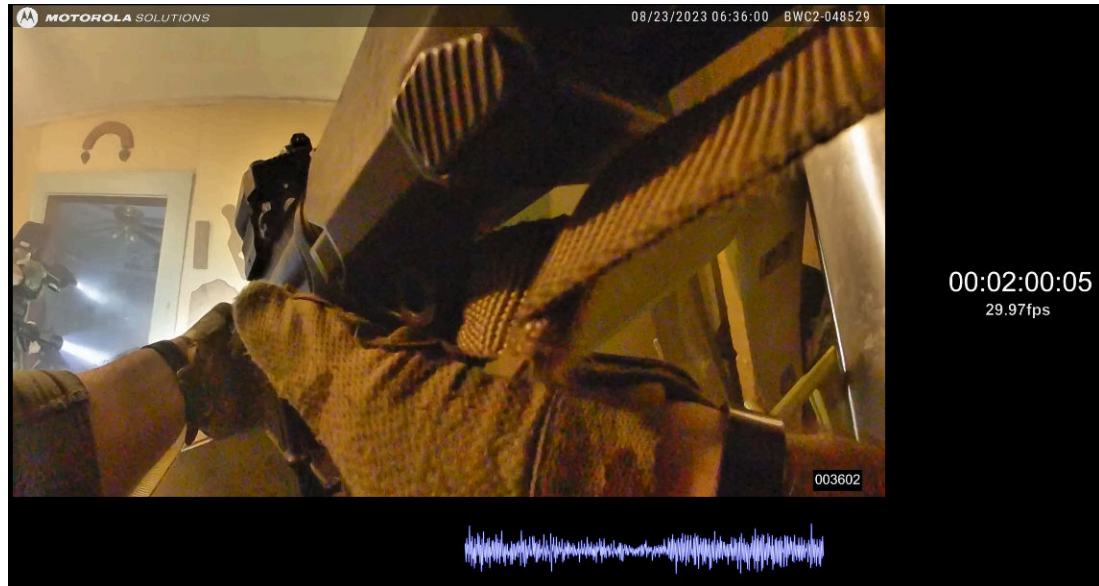
