**Narrative:**

On Wednesday, September 28, 2022, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Tuscarawas County Sheriff's Office (TCSO) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred at 5611 East Third Street, Mineral City, OH 44656, Tuscarawas County. BCI Special Agent Joseph Goudy responded to assist, arriving at approximately 1200 hours. Also responding from the BCI Special Investigations Unit were Special Agents Jon Lieber, Arvin Clar and Charlie Snyder. Special Agent Supervisor Dave Posten also responded. Additionally, the BCI Crime Scene Unit was requested to process the scene by documenting and collecting pertinent evidence.

The shooting incident involved the subject, Everett Martin, and members of the TCSO. The incident resulted in the death of Everett Martin; in which, he was transported to the Cuyahoga County Regional Medical Examiner for an autopsy by the Tuscarawas County Coroner's Office.
