### Narrative:

On Friday, May 3, 2024, at 1326 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy), received the evidence collected by the Crime Scene Unit (CSU) pertaining to the officer involved critical incident (OICI). The evidence collected by CSU, along with the duty weapons collected from the officers involved in the shooting by SA Goudy and Special Agent Supervisor (SAS) Chuck Moran (Moran), were transported to the BCI Richfield office and placed into temporary evidence locker #1 to be entered into Matrix and transferred into evidence.
