Narrative:

On Thursday, June 13, 2024, at approximately 0220 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by Chief Carl Davis of the Youngstown Police Department (YPD) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved shooting which occurred in the area of [REDACTED], Youngstown, Ohio. BCI Special Agent (SA) Jon Lieber (Lieber) responded to assist, arriving at approximately 0428 hours. Also responding from the BCI Major Case Response Team were Special Agents Charlie Snyder, Stacey Fifer, and Orlando Almonte. Additionally, the BCI Crime Scene Unit was requested to process the scene by documenting and collecting pertinent evidence.

The shooting incident involved a subject, Mathue O'Malley (O'Malley), and members of the Youngstown Police Department. The incident resulted in the death of O'Malley.
