MY DEAR GOVERNOR:—In pursuance of the provisions of house bill No. 315, which was filed in the office of the secretary of state May 19, 1919, being an act entitled: "An act to authorize the governor to convey to the village of Hicksville, Defiance county, Ohio, certain land located therein," a deed has been prepared by the Attorney-General in conjunction with the auditor of state, conveying to the said village of Hicksville all the title and interest acquired by the state of Ohio to the premises conveyed by said village to the state as a site for armory purposes, which said premises are fully described in said act.

It is believed that said deed, which is enclosed herewith, when properly executed and delivered will meet with the requirements of the act.

If said deed in your opinion is proper, you are requested to sign and seal the same and send it to the secretary of state in order that he may countersign and transmit said deed to the auditor of state to be recorded and forwarded to the village of Hicksville.
