LEASE—RESERVOIR LAND, STATE TO MARJORIE ANN KASCH, DESIGNATED LAND, STUBB'S LANDING, INDIAN LAKE, STOKES TOWNSHIP, LOGAN COUNTY.

COLUMBUS, OHIO, May 12, 1939.

HON. D. G. WATERS, *Conservation Commissioner, Columbus, Ohio.*

DEAR SIR: You have submitted for my examination and approval a certain reservoir land lease in triplicate, executed by the State of Ohio, through you as Conservation Commissioner to Marjorie Ann Kasch of Lakeview, Ohio.

By this lease, which is one for a term of fifteen years and which provides for an annual rental of \$13.20, there is leased and demised to the lessee above named, permission to use for private docklanding, lawn and walkway purposes only, that portion of the inner slope and waterfront that is included in Embankment Lot No. 15, north of Stubb's Landing, at Indian Lake, and being a part of the Southeast Quarter of Section 27, Town 6 South, Range 8 East, Stokes Township, Logan County, Ohio.

Upon examination of this lease, I find that the same has been properly executed by you as Conservation Commissioner and by said lessee. I further find, upon consideration of the provisions of this lease and of the conditions and restrictions therein contained, that the same are in conformity with Section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith returned.
