APPROVAL—CANAL LAND LEASE EXECUTED BY THE  
STATE OF OHIO TO ONE V. R. CUTSHALL OF FRESNO,  
OHIO.

COLUMBUS, OHIO, November 22, 1937.

Ohio.*

DEAR SIR: You recently submitted for my examination and approval a canal land lease executed by you as Superintendent of Public Works and as Director of said department to one V. R. Cutshall of Fresno, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$15.00, there is leased and demised to the lessee above named the right to occupy and use for agricultural purposes that portion of the Ohio Canal property, including the full width of the bed and embankments thereof in Lot No. 3, of the first quarter of the fifth township and fifth range of United States Military Lands in Lafayette Township, Coshocton County, Ohio, commencing at the line between the lands of I. H. Norman and Ethel L. West, being at or near station 3284+46 of G. F. Silliman's Survey of the Ohio Canal south of Massillon, and running thence easterly sixteen hundred and seventy-six (1676') feet, more or less, to the easterly line of the lands owned by said Ethel L. West and containing four and five-tenths (4.5) acres, more or less; and being the canal property formerly under lease to Ethel L. and Roy West, of Fresno, Ohio.

Upon examination of this lease, which is executed by you under the authority of an Act of the 89th General Assembly enacted April 29, 1931, 114 O. L., 541, I find that the same has been executed by you in your official capacity above stated and by V. R. Cutshall in the manner provided by law.

Assuming, as I do, that this property has not been designated for state highway purposes and that no application for the lease of the same has been made by any of the corporations or persons having prior rights to the lease of this property under section 8 of said Act, I find that the terms and provisions of this lease and the conditions and restrictions therein contained are in conformity with the above mentioned Act of the legislature and with other related statutes. I am, therefore, approving this lease, as is evidenced by my approval endorsed upon the lease and

upon the duplicate and triplicate copies thereof, all of which are herewith enclosed.

DEAR SIR: You recently submitted for my examination and approval a canal land lease executed by you as Superintendent of Public Works and as Director of said department to one G. Edgar Schumacher of Baltic, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$9.00, there is leased and demised to the lessee above named the right to occupy and use for residential and agricultural purposes that portion of the abandoned Ohio and Erie Canal property, including the full width of the bed and banks thereof, located in Lafayette Township, Coshocton County, Ohio, which is described as follows:

Beginning at a line drawn at right angles through Station 3217+00 of G. F. Silliman's survey of said canal property and running thence westerly with the lines of said canal property two hundred (200') feet to a line drawn at right angles through Station 3219+00, same being the east line of a lease granted to H. S. Zinken under date of May 21st, 1937, and containing twenty-one thousand and eighty (21,080) square feet, more or less; reserving therefrom any portion of the above described property that may be occupied by a public highway.
