Narrative:

On Wednesday, July 17, 2024, at 2330 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Eric Lehnhart (SA Lehnhart) transported items of evidentiary value to the Richfield Northeast Regional Office from 555 Independence Drive, Medina, Ohio 44256.
