Narrative:

On Monday, September 08, 2025, the Ashtabula County Sheriff's Office (ACSO) requested Bureau of Criminal Investigation (BCI) assistance at the scene of an officer-involved critical incident at the intersection of Stanhope-Kellogsville Rd. and Anderson Rd., Denmark, Ohio 44032, Ohio. As part of that investigation, Special Agent (SA) Dan Boerner (SA Boerner) was requested to attend the post-mortem examination of the decedent (OU2025-00350). The examination was conducted on September 9, 2025, at the Cuyahoga County Medical Examiner's Office in Cleveland, Ohio. The post-mortem examination was conducted by Dr. David Dolinak (ddolinak@cuyahogacounty.gov).

The following observations were made during the course of the autopsy:

SA Boerner requested to receive a copy of the full autopsy and toxicology reports once available.

As a result of the autopsy, the following items of evidence (Cuyahoga County Regional Forensic Science Laboratory # 2025-00714) were collected and transferred to the custody of SA Boerner:




