Narrative:

On Tuesday, June 18, 2024, the Ohio Bureau of Criminal Investigation (BCI) was requested by Chief Daniel Chafin of the Wadsworth Police Department (WPD) to conduct an independent investigation of the facts and circumstances surrounding an officer-involved critical incident shooting which occurred in the area of 223 Durling Drive, Wadsworth, Medina County, Ohio. BCI Special Agent (SA) Eric Lehnhart (SA Lehnhart) responded to assist, arriving at approximately 2339 hours. Also responding from BCI was SA John Tingley, SA Orlando and Special Agent Supervisor Chuck Moran. Additionally, BCI Crime Scene Unit Special Agent Laurna McClintock and Evidence Technician Mike Rostocil processed the scene by documenting and collecting pertinent evidence. The officer-involved critical incident shooting involved a subject, Shannon Sloan (Sloan), and members of the WPD. The incident resulted in the death of Sloan. A copy of the request for assistance letter is attached to this investigative report.

Medina County Prosecutor Forrest Thompson was on scene prior to SA Lehnhart's arrival. Medina County Coroner Dr. Lisa Deranek, M.D. arrived on scene to examined the decedent prior to him being transported to Cuyahoga County Medical Examiner's Office for a post mortem examination.
