APPROVAL—CANAL LAND LEASE, STATE OF OHIO, THROUGH DEPARTMENT OF PUBLIC WORKS, WITH HELEN M. DOBSON, COLUMBUS, OHIO, TERM FIFTEEN YEARS, ANNUAL RENTAL, \$12.00, LOT NO. 2, BALTIMORE ROAD, FAIRFIELD COUNTY, OHIO, FOR COTTAGE SITE AND GARDENING PURPOSES.

DEAR SIR: This is to acknowledge the receipt of your recent communication with which you submit for my examination and approval a certain canal land lease in triplicate executed by you as Superintendent of Public Works and as Director of said department to one Helen M. Dobson of Columbus, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$12.00, there is leased and demised to the lessee above named the right to occupy and use for cottage site and gardening purposes, that portion of the state's allotment of the Spoil Embankment on the west side of the Ohio Canal, south of what is known as the Refugee Road, that is included in Lot No. 2, of said allotment, said lot having a frontage of one hundred (100') feet on what is commonly known as the Baltimore Road, and being a part of Section 4, Town 16, Range 18, Fairfield County, Ohio.
