#### Narrative:

On March 27, 2024, Ohio Bureau of Criminal Identification and Investigation (BCI) Special Agent Ryan Scheiderer (SA Scheiderer) reviewed records associated with two prior Columbus Division of Police (CPD) calls for service at 500 N. Nelson Road, Apartment 105, involving Colin Jennings (Jennings) that occurred in February of 2024. The following is a summation of each incident. The Computer Aided Dispatch (CAD) records for the incidents are attached and available for review. Additionally, CPD provided Body Worn Camera (BWC) recordings, 911 call recordings, and radio traffic recordings for those incidents.

#### Incident P24008136 (February 04, 2024 at 10:48)

Caller, Chris Stone (Stone), reported that his boyfriend, Jennings, took pills in attempt to kill himself (radio code 47A) and had a paring knife in his hand. Stone reported Jennings made

comments that officers would have to shoot him. Stone reported that this was the 3<sup>rd</sup> or 4<sup>th</sup> time Jennings had attempted suicide.

When officers arrived on scene, Jennings was waiting for them inside the apartment building near the front exit. Jennings started walking towards his apartment, and Stone alerted officers that Jennings possessed a knife. When confronted by officers about the knife, Jennings retrieved a knife concealed in his waistband and tossed it to the floor. The knife was secured by officers. Jennings spoke with officers inside his apartment and ultimately Jennings agreed to be transported by squad to Grant Medical Center for an evaluation.

#### Incident P240107887 (February 14, 2024 at 20:52)

Stone called CPD requesting a well-being check on Jennings due to concerns he may be

harming himself and described Jennings as acting "inebriated". Stone described the February 02, 2024, incident to Dispatch including Jennings having a knife during that incident. Stone was not at the residence at the time he placed the call to CPD. Two CPD officers responded and knocked on the door to Apartment 105. No one answered and officers left without ever contacting Jennings.
