APPROVAL—CANAL LAND LEASE, STATE OF OHIO
THROUGH SUPERINTENDENT OF PUBLIC WORKS,
WITH OHIO POWER COMPANY, NEWARK, OHIO,
TERM FIFTEEN YEARS, ANNUAL RENTAL \$36.00,
RIGHT TO ERECT, MAINTAIN AND OPERATE ON OHIO
AND ERIE CANAL PROPERTY, DOVER TOWNSHIP,
TUSCARAWAS COUNTY, OHIO, CERTAIN DESCRIBED
HIGH TENSION POLE LINE.

DEAR SIR: This is to acknowledge the receipt of your recent communication with which you submit for my examination and approval a canal land lease executed by you as Superintendent of Public Works and as Director of said department to the Ohio Power Company of Newark, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$36.00, there is leased and demised to the lessee above named the right to erect, maintain and operate on the Ohio and Erie Canal property in Dover Township, Tuscarawas County, Ohio, one high tension pole line consisting of fourteen poles and six anchors, beginning at a point near station 1441 of G. F. Silliman's Survey of said canal property; thence northwesterly on said canal property, a distance of thirty-nine hundred (3900') feet, more or less, to station 1480.

Upon examination of this lease, which is executed by you under the authority of an Act of the 89th General Assembly enacted April 29, 1931, 114 O. L., 541, I find that the same has been executed by you in your official capacity above stated and by the Ohio Power Company, acting by the hands of its Vice President and Secretary pursuant to a resolution of the Board of Directors of said Company duly adopted under date of February 1, 1938.

Assuming, as I do, that this property has not been designated for state highway purposes and that no application for the lease of the same has been made by any of the corporations or persons having prior rights to the lease of this property under section 8 of said Act, I find that the terms and provisions of this lease and the conditions and restrictions therein contained are in conformity with the above mentioned Act of the legislature and with other related statutes. I am, therefore, approving this lease, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof, all of which are herewith enclosed.
