GENTLEMEN:—I am in receipt of your letter of June 12, 1926, enclosing for my approval a contract in duplicate, proposed to be entered into on behalf of the State of Ohio with The Cleveland, Cincinnati, Chicago and St. Louis Railroad Company and covering the distribution of costs and the division of the work between the state and company in connection with the construction of a separated crossing at the intersection of I. C. H. No. 130, Main Market Road No. 14, and the tracks of said company at Huntsville, Logan county, Ohio.

You also transmit the duplicate original certificate of county funds executed by the county auditor of Logan county under date of May 17, 1926, certifying county funds to this project in the sum of \$21,611.21, and a certified copy of a resolution adopted by the county commissioners of Logan county, adopted May 17, 1926, in which there is appropriated county funds in the sum of \$21,611.21.

Investigation in your department discloses that you have procured from the Director of Finance his certificate under date of June 15, 1926, in the sum of \$21,611.21.

I have carefully examined said contract and find it correct in form and legal, and am therefore returning the same to you with my approval endorsed thereon in duplicate.
