On 08/03/2019, at approximately 0252, Officers responded to 329 N Elizabeth in reference to an assault. Officers were advised by the victims, the def had forced his way into the residence of apt 2 and assaulted the residence causing minor injuries that were treated on the scene by paramedics. Officers attempted to locate the def at apt 3. Jose Oppenheimer answered the door and advised the def had fled out the back door of the residence. Officers observed the def running northbound on N Elizabeth. Officers were able to stop the def in the 400 BLK of N Elizabeth.

The def was observed to be inebriated. The def had red glossy blood shot eyes, slurred speech, unsteady afoot, and the odor of an alcoholic beverage coming from his breath and person. The def was placed under arrest for Aggravated Burglary and Intoxication.

It was later discovered the def had tossed a brick at the windshield of John Jamison's vehicle causing damage prior to entering the residence of Apt 2.

The def was transported to ACSO for holding and charged with Aggravated Burglary, Intoxication, and Criminal Damaging.

On 08/03/2019, at approximately 0252, I responded along with Pcl Luedeke to 329 N Elizabeth in reference to an assault. I observed John Jamison and Richard Gilbert at Apt 2. John advised he heard someone pounding on the front door of his apartment. John opened the door and observed James Haynes standing outside his door. James struck John with a close fist multiple times. James pushed his way past John and went into Richard's room. James assaulted Richard by striking him with a closed fist multiple times before he fled back to his apartment number 3. John advised James was a black male with a black shirt on. An ambulance was called and paramedics treated John and Richard's injuries on scene.

I knocked on apartment #3 and could hear a muffled male voice coming from inside of the apartment. Approximately one minute later, Jose Oppenheimer opened the front door. I asked if he was James and he said no. Jose advised James came into the apartment and got into a physical altercation with Steven Radcliff. James fled out the back door of the apartment when he heard police knocking at his door.

I ran out of the apartment and observed a black male with a black shirt, later identified as James, pacing back and forth at the eastbound train on N Elizabeth. I ran to my patrol car and observed the train pass by. I traveled northbound and observed James run eastbound crossing N Elizabeth. I initiated my overhead lights and gave loud verbal commands for James to stop. I was able to place James into my custody without further incident. I observed James to have red glossy blood shot eyes, slurred speech, unsteady afoot, and the odor of an alcoholic beverage coming from his person and breathe.

I returned to 329 N Elizabeth with James. Jose advised me James tossed a brick at the windshield of Allen Millner's vehicle before he assaulted John and Richard. I spoke with Allen and collected his information.

I spoke with Steven who advised nothing had happened and he didn't want to see James get in trouble. Steve advised James just had too much to drink. I took photographs of John, Richard, and Allen's vehicle.

I transported James to ACSO and he was charged with Suspicion of Aggravated Burglary, Criminal Damaging, and Intoxication.

Contact was made with RP#1 at the incident location where she advised that she had received information from RP#2-3 (family friends) that VI#1-2 (her daughters) had been sexually assaulted by OF#1 (her ex-boyfriend). RP#1 further advised that she lives at the incident location with OF#1, along with IO#2 (her current boyfriend). RP#1 stated that she allowed VI#1-2 to stay with RP#2-3 the previous evening. RP#1 further stated that on this date she received a call from RP#2-3 who advised her that OF#1 had sexually assaulted VI#2-3. RP#1 advised that she then spoke with VI#2 via "facetime" at which time VI#2 told her "OF#1 touches me here" while pointing to her genitals. Contact was made with IO#2 who corroborated RP#1's statements and advised that he watched the "facetime" conversation between RP#1 and VI#1-2.

RP#2-3 then arrived on scene with VI#1-2. Contact was made with RP#3 (boyfriend of RP#2) who advised that he was watching VI#1-2 while RP#2 took a nap. RP#3 stated that "VI#1-2 told me that they had to use the bathroom but were scared, and asked me to go with them." RP#3 further stated that he asked VI#1-2 why they were scared to use the bathroom at which time they advised "because OF#1 touches our privates in the bathroom." RP#3 advised that he stood outside the bathroom door while VI#2 used the bathroom. RP#3 further advised that VI#2 then asked him to come into the bathroom to help her and he discovered blood in the toilet.

Contact was made with RP#2 who stated that after the incident in the bathroom, RP#3 advised her of what VI#1-2 told him. RP#2 further stated that she then began questioning VI#1-2. RP#2 advised that VI#1-2 corroborated what she was told by RP#3 and that "RP#1 told me to let OF#1 touch my privates."

A taped statement was collected from RP#1-3 and a written statement was collected from IO#2. IO#1 and major crimes detectives arrived on scene.

This officer then responded to OhioHealth Mansfield with IO#1, RP#2-3, and VI#1-2 for interviews. This officer observed IO#1 interview VI#1-2 from a separate room via CCTV. While IO#1 interviewed VI#2, VI#2 could be heard stating that OF#1 "touched my butt and my pooch with his hand while it was under my clothes" while they slept together in the living room of the home. VI#2 also advised that two nights prior, "OF#1 put his penis in my pooch." VI#2 stated that RP#1 may have been in a chair in the same room during one of the incidents.

IO#1 then interviewed VI#1 who denied any sexual abuse against herself, however, stated that she observed "OF#1 put his penis inside VI#2's pooch."

VI#1-2 were admitted to the hospital for SANE examinations. Photographs were taken; see film pack 11673, frames 45-53.

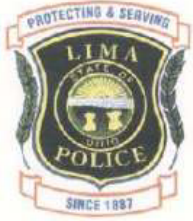

I observed James to have red glossy blood shot eyes, slurred speech, unsteady afoot, and the odor of an alcoholic beverage coming from his person and breathe.

I returned to 329 N Elizabeth with James. Jose advised me James tossed a brick at the windshield of Allen Millner's vehicle before he assaulted John and Richard. I spoke with Allen and collected his information.

I spoke with Steven who advised nothing had happened and he didn't want to see James get in trouble. Steve advised James just had too much to drink. I took photographs of John, Richard, and Allen's vehicle.

I transported James to ACSO and he was charged with Suspicion of Aggravated Burglary, Criminal Damaging, and Intoxication.
