## ORIGINAL INVESTIGATION

### ASSIGNMENT:

On Thursday June 2, 2022 while off duty we received the following assignment; FULL UDFIT Call-up at 3495 East 98<sup>th</sup> Street CMHA PD involved in a shooting. 50 year old male GSW to the chest. CMHA Officer sustained minor injuries. CAD 155158. We then learn that the 50 year old male expired at UH Hospital. CAD 2022-155158.

I immediately notified the Chief Dispatcher and then responded to the Crime Scene.

### EVIDENCE:

This firearm belongs to Sgt. [REDACTED] and was recovered on the north bedroom floor along the south wall. This item measured to be 2' west of the bedroom entrance and 5" north of the south wall. **Marker # 12: Swabs of Suspected Blood** were recovered from the north bedroom on the south wall. This area was just west of the bedroom entrance. The swabs of suspected blood were placed in the **Homicide Unit Property Book Page 04, Line 21.**

**Marker # 13: Swabs of Suspected Blood** were recovered from the bathroom on the west shower wall. The swabs of suspected blood were placed in the **Homicide Unit Property Book Page 04, Line 22.**

**Marker # 14: Defect** to the north bedroom exterior side of the door. This defect measured to be 6'7" up from the floor and 1'11" to the right of the west edge of the door.

**Marker # 14A: Defect** to the east bedroom wall just behind the entrance door. This defect measured to be 6'8" up from the floor and 9" north of the south wall. This defect was aligned with **Marker # 14.**

**Marker # 14B: Defect** to the northwest corner of the closet which is in the northeast corner of the living room. This defect measured to be 6'9" up from the floor. This defect was aligned with **Marker # 14 & 14A.**

**Marker # 14C: Defect** to the east wall of the closet which is in the northeast corner of the living room. This defect measured to be 6'9" up from the floor and 8" south of the north wall. This defect was aligned with **Marker # 14, 14A & 14B.**

**Marker # 18: One Spent 9mm Cartridge Casing** was recovered on the north bedroom floor to the west of the bedroom entrance. This item measured to be 1' north of the south wall and 5'9" west of the bedroom entrance. This item was placed in the Homicide Unit Property Book Page 4, Line 12.

Swabs of Touch DNA were obtained from the **three (3) Spent 9mm Cartridge Casings (Marker # 2, 3 & 8)**. The swabs were placed in the Homicide Unit Property Book Page 02, Line 24.

Swabs of Touch DNA were obtained from the **Glock Model 17, 9mm handgun with Serial # \_\_\_\_\_**. The Swabs were placed in the Homicide Unit Property Book Page 04, Line 25.

### SCENE:

The location of occurrence for this incident is 3495 East 98<sup>th</sup> Street Apartment # 703. This is a CMHA property which is located at the northeast corner of East 98<sup>th</sup> and Union Avenue.

Apartment # 703 is on the seventh floor at the north end of the hallway on the west side of the hallway. Upon entry into the apartment there is the kitchen. The kitchen measured to be 8' from east to west and 11' from north to south. We found there to be **suspected blood (Marker # 8)** on the floor of the kitchen to the west of the entrance. There is a table along the south wall. We recovered a **plastic bag of suspected narcotics (Marker # 9)** on top of the table.

To the west of the kitchen is the living room. The living room measured to be 12'9" from east to west and 10'6" from north to south. There is a couch along the north wall and a fish tank along the south wall. The entire floor was covered with clothing and miscellaneous items.

## ORIGINAL INVESTIGATION

There is a glass door on the west side of the living room that leads out to a patio. The glass door was found to be shattered and glass was all over the living room and patio floor. There was a bike and miscellaneous items all over the floor to the patio. Refer to reports completed by Det. POWELL # 2062 for details concerning items which were thrown to the ground on the outside of this building below this patio.

The entrance to the north bedroom is along the north wall of the living room. There is a closet in the northeast corner of the living room next to the entrance to the bedroom. We found there to be a **defect (Marker # 14)** to the top of the door leading into the north bedroom. There was also **suspected blood (Marker # 11)** on the exterior side of the north bedroom door.

The north bedroom measured to be 8'5" from north to south and 16'11" from east to west. We found there to be a **defect (Marker # 14A)** to the east bedroom wall behind the entrance door. This defect was aligned with **defect # 14**. There were also a **defect (Marker # 14B)** to the northeast corner of the closet in the living room and a **defect (Marker # 14C)** to the east wall of the closet. Both **Defect 14B & 14C** were aligned with **Defect's 14 & 14A**.

We recovered the following evidence on the north bedroom floor just inside and to the north of the entrance; **Two (2) Spent 9mm Cartridge Casings (Marker # 2 & 3)**, **Tazer (Marker # 4)**, **Tazer Dart (Marker # 5)** and **CMHA PD Hat (Marker # 6)**.


There is a bed along the west wall and a night stand with a fish tank on top in the southwest corner of the bedroom. There is a window along the west wall. We recovered a **Sig Sauer Firearm Frame (Marker # 7)** on the window sill.

We found there to be **suspected blood splatter (Marker # 10)** on the north bedroom wall. There was also **suspected blood splatter (Marker # 12)** to the south bedroom wall just west of the entrance to the bedroom.
