**Narrative:**

On August 11, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joshua Schlie responded to the Warren County Sheriff's Office at 822 Memorial Drive, Lebanon, Ohio, to photograph Deputy [REDACTED] and recover the patrol rifle that he utilized in an Officer-Involved Critical Incident, earlier in the day.

SA Schlie arrived at approximately 1352 hours and photographed Deputy [REDACTED] from the front, left side, right side, and rear. SA Schlie also photographed Deputy [REDACTED] pistol and magazines, although it was reported that they were not used in the incident.

SA Schlie also photographed and then took possession of a Smith & Wesson rifle, model M&P 15, serial [REDACTED]. A black P-Mag, magazine, marked "WCSO" in white paint, and loaded with ammunition, was also photographed, along with one (1) round of ammunition removed from the chamber of the rifle by SA Schlie.

SA Schlie secured the rifle, magazine and one (1) loose round of ammunition in a white, cardboard evidence box and transported it to the Ohio State Highway Patrol's (OSHP) Lebanon Post, located at 184 Nelson Rd., Lebanon, OH. Once there, SA Schlie transferred custody of the evidence box, containing the rifle, magazine and one (1) loose round of ammunition to SA Chad Holcomb.


SA Schlie placed 17 photographs into the files section of this Matrix case.
