Narrative:

On Sunday, July 24, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent Andrew Russell (SA Russell) conducted a neighborhood canvass in the area of 1132 Ashwood Drive, South Charleston, Ohio. The purpose for the canvass was to identify and interview potential witnesses to the officer-involved shooting that occurred at 1132 Ashwood Drive, South Charleston, Ohio, on Sunday, July 24, 2022.
