APPROVAL, ABSTRACT OF TITLE TO LAND IN VILLAGE OF BROOK
PARK, CUYAHOGA COUNTY, OHIO, FOR MILITARY PURPOSES.

DEAR SIR:—You have submitted for my examination and opinion copy of a form of proposed deed between the City of Cleveland, as grantor, and the State of Ohio, as grantee, conveying to said the State of Ohio the following described real estate:

Situated in the village of Brook Park, County of Cuyahoga and State of Ohio and known as being part of original Middleburg Township Lot No. 3 in Section 20 and bounded and described as follows:

Beginning in the westerly line of land conveyed to William Loga by deed recorded in Volume 2054, page 437 of Cuyahoga County Deed Records, at a point 60 feet northerly by rectangular measurement from the center line of Five Points Road; thence westerly parallel with said center line of Five Points Road, 400 feet; thence northerly parallel with said westerly line of William Loga's land, 500 feet; thence easterly parallel with said center line of Five Points Road, 400 feet to said westerly line of William Loga's land; thence southerly 500 feet to the place of beginning.

Said deed recites that the premises are conveyed to the State of Ohio for military purposes, and whenever said premises shall cease to be used for military purposes, then the title to said premises shall immediately revert to the grantor, its successors and assigns, and all rights of the grantee shall thereupon cease and determine.

Finding said copy of the proposed deed in proper legal form, I hereby approve the same and return the same to you herewith.
