Narrative:

On June 20, 2024, at about 1525 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Chuck Moran (Moran) went to the Wadsworth Police Department (WPD) and met with Detective Dakota Lamielle (Lamielle).

SAS Moran returned two rifles to Detective Lamielle. The rifles were:

- Matrix Evidence Item 021 - Rifle, Palmetto State Armory, PA-15 Multi, Serial Number [REDACTED] red colored "15" marked above magazine well.
- Matrix Evidence Item 023 - Rifle, Palmetto State Armory, PA-15 Multi, Serial Number [REDACTED] red colored "14" marked above magazine well.

An evidence receipt was completed for the return of the rifles. The evidence receipt is attached to this report. The evidence receipt showing SAS Moran's acquisition of the rifles from BCI is also attached to this report.

Note: On June 20, 2024, at 1157 hours, SAS Moran spoke with Prosecutor Forrest Thompson by phone about the rifles and how they were likely not fired during the incident. Prosecutor Thompson verbally authorized the release of both rifles to the WPD.
