Comments: Case Synopsis: It was reported that John Perry who resides at 2212 Tryon Road, Ashtabula, pointed a shotgun at a neighbor. The neighbor called the police and eventually a standoff ensued between Perry and a SWAT Team. During the standoff it was reported that Perry discharged his firearm on at least one occasion towards SWAT Team members. Two SWAT Team members returned fire. Perry was struck and was later found dead inside his residence.
