Narrative:

On March 19, 2025, at approximately 0445 hours, regarding the officer-involved critical incident that occurred on I-75 in Evendale, Ohio (Hamilton County) earlier that morning, Ohio Bureau of Criminal Investigation (BCI) Special Agent Dave Hornyak obtained an initial briefing from Chief Mike Ott of the Lockland Police Department. Chief Ott advised that multiple agencies had responded to the Evendale area to assist with the pursuit of a stolen vehicle where the occupants had bailed out near I-75. Lockland encountered an individual on I-75 near mile marker 14, and reported over the radio that the subject was uncooperative and would not show his hands. The encounter resulted in shooting the subject, who was shortly thereafter pronounced deceased and is still unidentified.

Chief Ott stated that was not equipped with a body-worn camera (BWC) as LPD is currently testing BWCs and currently only has four in use for all officers. Chief Ott also stated that LPD cruisers are not equipped with dash cams.

While enroute to the location, SA Hornyak provided Chief Ott with the initial expectations of BCI along with information about how agents would proceed upon arrival. The agent also provided estimated arrival times of both SIU and Crime Scene personnel.

At the scene, SA Hornyak also met with Chief Tim Holloway of the Evendale Police Department whose agency had jurisdiction. Official requests for investigation were later received from both the Evendale and Lockland Police Departments.

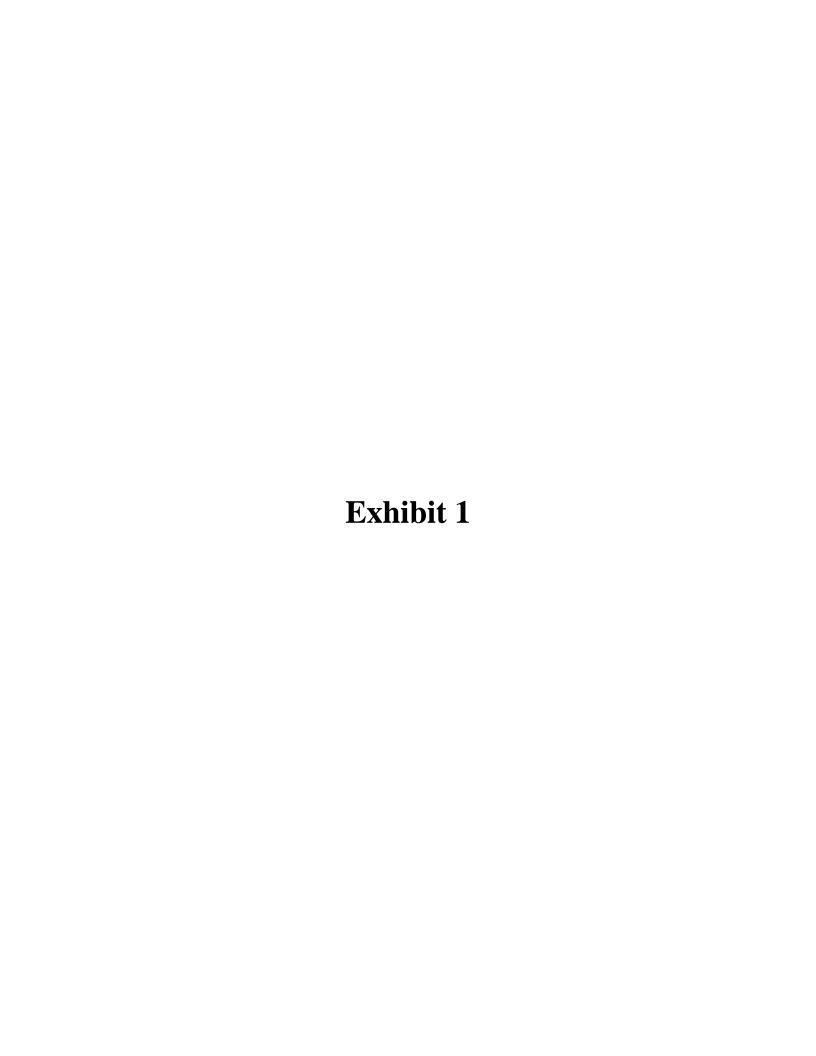

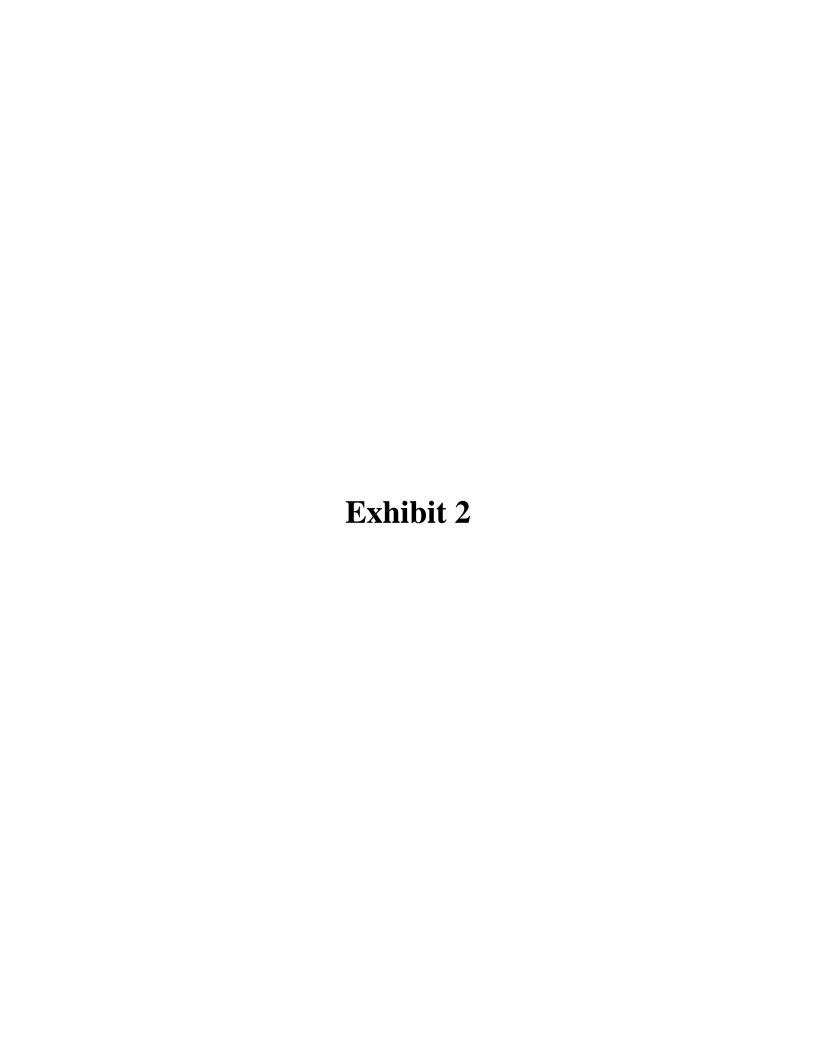
